1. BACKGROUND

Many communities in Jamaica are vulnerable and face challenges due to multiple human insecurities. The Government of Jamaica (GOJ) is committed to addressing these human insecurities to promote social and economic development while protecting the natural environment as articulated in the Vision 2030 Jamaica: National Development Plan (Vision 2030). It is also recognized that the complexity and interconnectedness of the human insecurities require a multi-sectoral, multi-dimensional and multi-level approach that is prevention-oriented, people-centered and partnership driven.

In an effort to address the diverse human insecurities in a comprehensive and holistic manner, the Joint United Nations (UN) Team comprising the Food and Agriculture Organization (FAO); the Pan-American Health Organization (PAHO); the United Nations Development Programme (UNDP)- inclusive of the Global Environment Facility (GEF) Small Grants Programme (GEF SGP) and the Japan Caribbean Climate Change Programme (JCCCP); the United Nations Environment Programme (UN Environment); the United Nations Educational, Scientific and Cultural Organization (UNESCO) and the UN Women In an effort to address the diverse human insecurities in a comprehensive and holistic manner, the Joint United Nations (UN) Team

comprising the Food and Agriculture Organization (FAO); the Pan-American Health Organization (PAHO); the United Nations Development Programme (UNDP)- inclusive of the Global Environment Facility (GEF) Small Grants Programme (GEF SGP) and the Japan Caribbean Climate Change Programme (JCCCP); the United Nations Environment Programme (UN Environment); the United Nations Educational, Scientific and Cultural Organization (UNESCO) and the UN Women partnering with the GOJ to implement the three-year "Strengthening human resilience in Northern Clarendon & West Kingston" Programme under the "Delivering as One" approach.

A comprehensive human security analysis revealed a wide range of threats and insecurities facing communities in Jamaica. The indicators of human insecurity are reflected across the portfolios of UN Agencies, justifying the need for an integrated approach to reduce vulnerabilities. The joint programme will allow for enhanced coordination and streamlining of resources and efforts to attain common programme objectives in the target communities. Four priority areas emerge as both the most prevalent and best suited for a joint UN programme, namely:

- Economic insecurity expressed in the form of poverty and unemployment, especially among youth and women, and low levels of rural development
- Environmental insecurity seen in vulnerability to natural hazards and the need to strengthen
 resilience to climate change and improve management of the use of natural resources such as
 water and land
- Personal insecurity expressed in the forms of political and community insecurity because of the high levels of crime in West Kingston
- Health insecurity due to limited infrastructure for and access to basic services such as water and sanitation.

The programme which is supported by the United Nations Trust Fund for Human Security (UN-TFHS) is aimed at enhancing resilience and human security of communities in Northern Clarendon and West Kingston in Jamaica. It will also seek to mainstream the human security approach in development strategies and support improvement in the policy and regulatory framework in water resources management. This will be achieved through four key objectives:

Objective One: Local and community governance bodies strengthened to design and oversee interventions to address insecurities

Objective Two: Enhanced economic, food and nutrition security in selected communities

Objective Three: Improved environmental health and water security at the community, local and

national levels

Objective Four: Institutional capacity for integration of Human Security Approach strengthened

This consultancy responds to Output 2.2 of the programme result framework: *Localization of Social enterprise opportunities related to human security expanded*. It is also a partial response to the complex and interconnected development challenges impacting the full attainment of human security within Northern Clarendon and West Kingston. Consequently, this consultancy will contribute to strengthening Human Resilience, by improving the economic well-being and quality of life of the community residents.

2. SCOPE OF WORK

The Consultant will undertake the activities outlined below under the supervision of the Joint Team of the UN/GOJ Human Security Joint Programme and specifically the Programme Management Unit.

Activity 1:

 Conduct a mixed design Gap Analysis (both quantitative and qualitative approaches should be used), to assess opportunities for viable Social Enterprises in selected communities of West Kingston & Northern Clarendon.

The report from the gap analysis should:

- Describe the social enterprise landscape in the targeted communities and reveal at minimum:
 - ten (10) existing Social Enterprises operated by registered community groups; or
 - ten (10) potential social enterprises.
- Present in detail, the strengths weaknesses, opportunities and threats affecting or could affect each enterprise (both existing and potential).
- Recommend 10 Social Enterprises for business development support and grant funding (the selection criteria used must be annexed in the final report).
- Present a development plan for the ten (10) recommended social enterprises. The plan should detail the <u>specific support</u> that will be provided to <u>each</u> entity based on their unique need.

Activity 2:

- Implement the development plan for the selected 10 social enterprises (Each targeted community must establish or strengthen a social enterprise venture).
- Provide technical support through mentorship, training, business coaching etc. to strengthen
 the capacity of the community groups to manage and maintain their social enterprises.

In order for the Consultant to achieve the aims and objectives above, he/she will undertake the following tasks inter alia, in the two parishes targeted under the Joint Programme:

- Desk Research
- Consultations
- Instrument Design
- Mobilization of Field workers
- Conduct Field work
- Data analysis including mutually agreed cross tabulations
- Production of report on Findings
- Organization and delivery of training
- Provide technical support during integration of the social enterprise model developed
- Establish relationships with key stakeholders
