Project background

INTRODUCTION

Tens of thousands of houses were badly damaged during the liberation of the city from ISIS. Families who have returned to their homes after liberation have found their homes and neighborhoods smashed and broken. Household goods have been looted or destroyed, fixtures and fittings damaged, and walls are punctuated with bullet holes. This damage is a tangible reminder of the immense suffering of families over the past years and impacts on people's sense of hope for the future of Iraq.

The primary aim of FFS' housing repair is to promote returns to liberated areas by improving housing quality, safety, and the dignity of returnee families. This project will help rehabilitate several thousand houses across the four areas of the west bank of the city to encourage people to return to their homes and back to normal life.

Phase1 Rehabilitation (323unit) of houses in Al-Risala South & Al-Risala North Neighborhoods has an estimated number of beneficiary families (323) about (3380) person, most of them are vulnerable families who have returned home.

PROJECT DESCRIPTION

Rehabilitation includes the provision of minimum basic housing requirements by providing at least two rooms (sleeping and living) with basic services (bathrooms and toilets) with kitchen. Security and safe, in terms of roof, walls, exterior fences, doors, windows, main door, electricity and water, each family (4-8 persons)

OBJECTIVE OF THE PROJECT

The main objective of the project is to provide safe and secure housing for families whose homes have been damaged by ISIS occupation and military operations in the liberated areas, and to contribute to the restoration of these areas, the restoration of normal life, the encouragement of people to return to their areas and return to their jobs, In addition to creating jobs for the inhabitants of these areas and pushing the local economy through their direct participation in the rehabilitation of homes.

Direct and indirect beneficiaries:

- Direct beneficiaries are homeowners (323), 1687 Male and 1693 Female.
- The indirect beneficiaries are the local population.

Impact and how it will be measured

Improve the Living conditions of the families in the neighborhoods and Encourage more families to return and family members to return to the neighborhood.
