Q: Is Team leader experience requires experience on local governance, democratization and fiscal decentralization, particularly to Myanmar?

A: Team Leader requires experience on local governance, democratization and fiscal decentralization. Experience in Myanmar would be an advantage but not a requirement.

Q: Whether UNDP could support scheduling and meeting with Government offices for this RFP?

A: UNDP will facilitate the process to coordinate meetings with the Government related to this RFP.

Q: Is there any preference Methodology by UNDP or it need to be proposed by the Firm?

A: The TOR includes a section on methodology which is broader. Firms are required to propose methodology for the MTR.

Q. Whether the firm can use the translator from UNDP's LTA? What would be the total work days for translator?

A: In case if the selected firm does not have a good translator, it is possible to hire a translator from UNDP LTA. The translator is required for 15 days during data collection phase.
