UNV will not accept bids that are hand delivered.
10	Evaluation of Bids	The bids will be reviewed by an evaluation team. The award will be offered to the highest qualified bid for each vehicle.
11	Notification to Successful Bidders	UNV will notify successful bidders upon completion of the bid evaluation.
12	Movement of Items	Upon receipt of notification from UNV, within seven days, the successful bidder should make the payment to the UNV bank account and provide proof of payment to procurement@unv.org. On receipt of the money, UNV will notify the bidder when they can pick up the vehicle. If the payment is not processed within the timeline, UNV reserves the right to offer to the next highest qualified bidder. It is the responsibility of the bidder to arrange the removal and transportation at their own expense. Any damages during the removal of the vehicle will be the responsibility of the bidder. The vehicle will be handed over without license plates. It is the bidder's responsibility to arrange new license plates.
