# A. Background

UNDP Mauritius Country Office aims to collect and disseminate stories from Mauritius, showcasing development impact towards the attainment of the Sustainable Development Goals (SDGs); and sharing supporting individuals, communities, civil society, the private sector and government to share socioeconomic human and environmental interest stories aimed at demonstrating development impact in partnership with UNDP.

UNDP Mauritius Country Office requires the services of two talented photographers with demonstrated competencies in documenting human interest and development stories through photography and videography. The photographer will be responsible for capturing examples of UNDP Mauritius in the governance, socioeconomic development and environment sectors. The photos and videos will aim to capture the projects, beneficiaries and development impact. The consultant will be required to take high resolution photographs in all weather conditions throughout Mauritius including in the twelve projects to be showcased around Mauritius and Rodrigues Islands (transportation and daily stipend fully covered by UNDP). He/she will also be required to caption the photographs with appropriate detail including dates, location and contact details of subjects to facilitate he development of a photo/video library.

# B. Scope of Work

#### **Duties and Responsibilities**

- Travel to UNDP's project sites in Mauritius and Rodrigues (1 mission of 3 days),
- Produce high quality photo and video products for UNDP's website, social media and other strategic publications;

# **Expected Outputs and Deliverables**

The successful photographer/videographer will be responsible for the following tasks and deliverables;

# Photography:

 Capture 300 good quality still photos from the field visits and events for use in UNDP website, social media and publications.

- The photos must be directly linked to UNDP's various programme/project activities with a focus of the theme's community, governance and environment.
- Captured photos and videos will showcase, but not be limited to, individuals, families, groups, events, buildings, objects, landscape, and scenery which reflect or directly relate to UNDP activities and programmes as agreed
- Captured photos of portraits, families, groups and communities should also be gender balanced;
- Edit selected photographs using relevant tools and appropriately caption including details on: location, name of subject (where appropriate), activity and any other relevant information)
- The photographer is to submit a selection of best photos per site/ programme to UNDP

# Videography

- Work closely with the Communications Team and project teams to produce videos/short videos for website and social media using the footage collected from the field visits and events;
- Produce short video interviews for UNDP's social media and website.
- The video recordings shall be provided in three versions:12 seconds-snippets, 2 minute-snippets and full interviews, and be optimized for both web and mobile. The video recordings shall include a description of the scene and project and include transcripts, when necessary, of all relevant dialogue from recordings, including time stamps, adhering to transcription style guide;
- Hand over all photos and video footages in RAW format and properly archived (as per relevant SDG and project) to UNDP on external memory medium or via file transfer service;

# **Quality Specifications**

- All work product will adhere to the following specific requirements for the photos and videos:
- Photographs must be provided at highest quality and at a minimum of 300 dpi, in JPG format, suitable for printing, processing or publishing on web;
- Interviews should be filmed and have a clear sound, allowing subject time to respond at length to prompts and questions provided;
- Videos/audio recordings should be at minimum 2 minutes each for interviews and 12 seconds for non-interviews, with a total of at least 30 minutes of interview footage per visit;
- Embedded subtitles in videos should be in Myriad Pro, Bold Semi-Condensed, in a readable size. Logo in video clips should be embedded as a watermark on the top right side, with 70% transparency;
- Final work to be submitted via online storage, such as Microsoft OneDrive, Google Drive, Dropbox or WeTransfer.

# **Action Plan and Operating Procedure**

- The photographer/videographer is expected to have an inception meeting/briefing with the Team Leader Environment, Communications Team and respective programme/project teams at the start of the assignment to agree a travel and workplan.
- The outputs and deliverables will be varied based on the projects and sites to be visited. The selected photographer(s) will also hold the responsibility of providing photo release forms, signed and compiled.
- Following the meeting with the and Project teams, the photographer will submit a workplan detailing
  the schedule of site visits and the shoot list for vetting. Where required, UNDP will liaise government
  institutions to grant access to sites earmarked for photo/video shooting.

#### **D.** Duty Station

• The Photographer/Videographer is expected to travel throughout Mauritius, including a 3-day mission to Rodrigues

# E. Requirements and Qualifications

- Minimum high school certificate is required
- Additional professional training in photojournalism is an added advantage;
- Demonstrated experience in technical photography and creative filming including strong photo and video, editing and compositional capabilities.
- Advanced knowledge and skills of editing software/tools such as Adobe Photoshop/lightroom, MS
   Office is an advantage.
- Experience in communication for development/ human interest photography is an advantage
- Possession of high-end photography (DSLR or mirrorless with appropriate multi focal/ prime lenses)
  equipment and associated accessories (artificial lighting, tripod, microphones) and drone, to capture
  aerial footage, will be an advantage.

#### F. Language Skills

- The consultant must be fluent in oral and written English.
- Fluency in French and/or Mauritian creole is an advantage

#### Notes

The applicant must be aware of <u>UNDP's General Condition of Contract</u>. The consultant must observe Minimum Operational Security Standards (MOSS) as communicated by the United Nations for the location(s) visited. The total amount quoted shall be all-inclusive and include all costs components required to perform the deliverables identified in the TOR, including professional fee (including daily rate), per diem (meals, transportation, accommodation), communication costs and any other applicable cost to be incurred by the consultant in completing the assignment. #### Criteria for Selection of Best Offer

Individual consultants will be evaluated based on the following methodology:

# Cumulative analysis

When using this weighted scoring method, the award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

- a) Responsive/compliant/acceptable technical proposal, and
- b) Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation

The award of the contract will be made to the candidate whose offer has been evaluated using the "Combined Scoring Method" whereby the selection will be based on a Combined Scoring Method where the technical proposal will be 70 per cent and combined with the price offer which will be weighted 30 per cent.

Candidates scoring a minimum of 70% of the maximum marks on the above criteria will be considered for the financial evaluation.

The offers will be evaluated under the Best Value for Money principles, which consists of the selection of the offer that best meets the end-user's needs and that presents the best return on investment. Fairness, Integrity and Transparency, which ensures that competitive processes are fair, open, and rules-based.

The final scoring of short-listed candidates will take into account the technical score and the financial score:
