5. FINANCIAL PROPOSAL

Financial proposal shall be submitted together with the compulsory documents, in the format provided in "**Letter to UNDP Confirming Interest and Availability**".

6. EVALUATION

The evaluation will be based on cumulative analysis (i.e. technical qualifications and price proposal). The weight of the technical criteria is 70% (consisting of CV based assessment and interview); the weight of the financial proposal is 30%. Candidates that obtain a minimum of 49 pts out of a maximum 70 pts will be considered for the financial evaluation. Candidates that do not meet the minimum requirements will be disqualified.
