A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared.

The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component. The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR). Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. Sf = 1000 x Fm / F, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected subject to positive reference checks on the consultant's past performance.

An additional interview either direct or through telephone/Skype will be applied if necessary.

#### 1 GENERAL BACKGROUND

# 1.1 Development Context and Policy Framework for Blue Economy Globally and in Viet Nam

Viet Nam is a marine country, and its rich history, traditions, culture, and process of building and defense have always been closely associated with the sea. Viet Nam has a long coastline of over 3,260 km (excluding islands), and its exclusive marine economic zone, at approximately 1 million km<sup>2</sup>, is almost three times as large as its land territory. Its waters are diverse, and each type of natural resource and ecosystem plays a unique role in the sustainable development and protection of Viet Nam's marine environment.

The concept of a "blue economy" came out of the 2012 Rio+20 Conference and emphasizes conservation and sustainable management, based on the premise that healthy ocean ecosystems are more productive and form a vital basis for sustainable ocean-based economies (UN DESA 2014a). The blue economy concept seeks to promote economic growth, social inclusion, and the preservation or improvement of livelihoods while at the same time ensuring environmental sustainability of the oceans and coastal areas. It aims to move beyond business as usual and to consider economic development and ocean health as compatible propositions.

The blue economy has diverse components, including established traditional ocean industries such as fisheries, tourism, and maritime transport, but also new and emerging activities, such as offshore renewable energy, aquaculture, seabed extractive activities, and marine biotechnology and bioprospecting.

The worldwide ocean economy is valued at around US 1.5 trillion per year. For example, aquaculture is the fastest growing food sector and provide about 50% of the fish for human consumption, while 350 million jobs world-wide are linked to fisheries. (Commonwealth).

A blue economy approach must fully anticipate and incorporate the impacts of climate change on marine and coastal ecosystems—impacts both already observed and anticipated. The East Sea holds significant importance to Viet Nam's strategic geography, economy, and natural resources. Cross-border environmental pollution, climate change, and sea level rise have become urgent global problems. Sustainable development and the goal of harmony between development and marine conservation have become major trends. Globalization and the revolution of science and technology have created many opportunities and challenges.

Within Viet Nam, macroeconomic stability, sustainable development, adaptation to climate change and sea level rise, security, and social safety present great difficulties and challenges.

#### 1.2 Relevant Policies and Initiatives for Developing a Blue Economy

#### By the International Community

The need for the sustainable management and development of marine resources is recognized globally, and a number of international initiatives, agendas, and laws are in place to regulate its use, for example, Agenda 21, the Johannesburg Plan of Implementation, various decisions taken by the Commission on Sustainable Development, the Rio+20 outcome document The Future We Want, and the 2030 Agenda for Sustainable Development. Furthermore, the 1982 United Nations Convention on the Law of the Sea (UNCLOS), sets out the legal framework within which all activities in the oceans and seas must be carried out, including the conservation and sustainable use of the oceans and their resources.

#### By the Government of Viet Nam

The Government of Viet Nam have introduced several important policies and initiatives relevant to the development of a strategy for a sustainable blue economy. The Law on Natural Resources and Environment of Sea and Islands was adopted in 2015 and on 22 October 2018, the Eighth Party Conference of the Central Executive Board Term XII promulgated

Resolution 36/NQ-TW on the Strategy for Sustainable Development of the Marine Economy of Viet Nam Until 2030, Vision to 2045 and the Ministry of Natural Resources and Environment (MONRE) is currently developing an action plan for implementation of Resolution 36. Furthermore, the Viet Nam Green Growth Strategy (VGGS) lays out a wider economic agenda for the path of sustainable development.

#### 2 OBJECTIVES OF THE ASSIGNMENT

In order to realize the objectives of the *Strategy for Sustainable Development of the Marine Economy of Viet Nam Until 2030, Vision to 2045*, as well as to assist Viet Nam in meeting its stated goals on socio-economic development and sustainable use and protection of marine resources, UNDP is looking for a team of one (01) International Consultant (IC) and eight (08) National Consultants (NC) to **develop a synthesis report on the potential contributions of the blue economy to the socio-economic development of Viet Nam**.

The **synthesis report** should be between 50 to 70 pages and will be w a policy paper written by the IC/Team Leader with assistance from NC1 and will include a concise executive summary of no more than 10 key recommendations and strategies taken from the 07 in-depth **thematic technical reports** to be conducted by NCs 1 through 7, each in specific thematic area. It will be complemented with a 5-page policy paper based the findings of the synthesis report.

While it is not the focus of this assignment, this first round of reports will help to set a foundation in place for a long-term regular review that takes into consideration the impact of the blue economy on each of the highlighted sectors by contributing to a better awareness of the challenges and opportunities presented by the blue economy in Viet Nam.

#### 3 SCOPE OF WORK

#### 3.1 Joint Tasks and Activities of the Team

To complete this assignment, the team will undertake the following activities:

#### I. Work Plan & Methodologies

Recognizing that each thematic area might call for a different approach according to its own distinctive context, consultants will be requested to submit their own **methodologies and work plans** in accordance with their respective thematic area. The IC/Team Leader and NC1/Co-Team Leader will also provide inputs and contributions to the proposed methodologies and work plans to each NC. Once submitted and approved by UNDP, consultants will collaborate to elaborate a further methodology.

# II. Thematic Reports

All consultants (NC1, NC2, NC3, NC4, NC5, NC6, and NC7), except NC8 will be responsible for producing a **thematic technical report** about their specific sector that is separate from the synthesis report but will be used to provide insight into its finalized content. The reports, which will have a primary focus on economic analysis and a secondary focus on the environmental and social dimensions of each sector, will have 5 primary components:

- 1. The current Vietnamese policy context and development status of their respective sector specifically for Viet Nam and with connection to global trends. under review.
- 2. The current contributions of the sector to GDP.
- 3. The challenges, opportunities, constraints, and potential future contributions of the sector to socio-economic development in Viet Nam.

- 4. Analyze the connection of the specific sector with international commitments, laws, free trade.
- 5. Map the linkages and co-benefits of the theme to the Sustainable Development Goals (SDGs) and the contribution to pre-identified cross-cutting themes, such as inequity, innovation and gender.

When drafting their report, consultants will be expected to:

- i. Collect, analyze, and review relevant data; consult with relevant stakeholders.
- ii. Provide a description of the thematic area in question.
- iii. As much as possible, provide linkages to both the other individual themes and to the vision of the project as a whole.
- iv. Include appropriate maps and infographics in the report.

# III. Synthesis Report

The main final product of the assignment is the production of a **synthesis report** combining the key elements of all the thematic reports produced by the consultant team. It will be an executive summary of between 60 to 80 pages that highlights key policy messages for decision-makers and will be compiled by the IC/Team Leader with support from NC1/Co-Team Leader and any additional support required by the rest of the consultant team. An initial draft of the synthesis report, internal to UNDP, must be submitted one month after all thematic reports are submitted. Further drafts will be submitted and revised according to feedback from peer reviews, UNDP, and consultations with relevant stakeholders before a final version is produced and sent to UNDP for approval.

Once the final draft is submitted to UNDP for review and is accepted, the IC will create a 5-page policy paper based on the final synthesis report.

#### 3.2 Specific Responsibilities of Team Members

#### 3.2.1 IC – International Consultant on the Blue Economy / Team Leader

#### **Tasks**

Tasks as Blue Economy Expert

- Carry out an economic analysis of the blue economy related to the economy as a whole, blue economy development trends, and the influence of the blue economy on other sectors and localities.
- Examine future direction/orientation of the blue economy and propose the transition to the blue economy in Viet Nam.
- Provide recommendations for improvement of budgeting, planning, and setting priorities to improve effectiveness and accountability in the implementation.
- Produce a draft and final synthesis report of between 60-80 pages combining the key elements of all thematic reports produced by the consultant team, with the support of the NC1/Co-Team Leader.

• Create a 5-page policy paper based on synthesis report after the final text of the full report has been submitted to and accepted by UNDP.

# Responsibilities as Team Leader

The role of the Team Leader has the following functions:

- Lead in the preparation of the overall work plan of the team, overall assignment and lead discussions with UNDP on the scope, methodology, timeframe, quality criteria, etc.
- Provide guidance on methodologies and workplan on each thematic report and scope and identification of key crossing themes for thematic reports.
