

I. BACKGROUND

UNDP partners with people at all levels of society to help build nations that can withstand crisis, and drive and sustain the kind of growth that improves the quality of life for everyone. On the ground in 177 countries and territories, we offer global perspective and local insight to help empower lives and build resilient nations.

This Call for Proposals (CFP) is specifically related to the UNDP project, **Preventing Violent Extremism** through Promoting Tolerance and Respect for Diversity (PROTECT).

II. OBJECTIVES AND EXPECTED OUTPUTS/ DELIVERABLES

The objective of this Call for Proposals is to support the ongoing PVE work of UNDP, through a series of online and offline initiatives. The aim of these initiatives is both to disseminate/promote actions for positive narratives on peace, tolerance and respect for diversity at community level to tackle Violent Extremism and to strengthen their capacities of communities in the dissemination of such among youth. In this regard, the selected NGOs/ CSOs will focus its efforts on undertaking several activities:

- 1. Conduct a series of video screening in promoting tolerance and diversity, in at least one (1) city in Sumatera, Java, Sulawesi and Maluku.
- Deliver a series of activities as tools to promote tolerance and respect for diversity, in at least one
 (1) city in Sumatera, Java, Sulawesi, and Maluku

Detailed objective and related outputs and deliverables are provided in the Terms of Reference – Annex 1

III. ELIGIBILITY & QUALIFICATION CRITERIA

The parameters that will determine whether a <u>NGO/CSO is eligible</u> to be considered by UNDP will be based on the <u>NGO/CSO Request for Information (RFI)</u> template.

It is expected that the NGO/CSO will meet the following qualifications:

- Experience in the area of prevention of violent extremism (PVE) and youth movement;
- Experience in the use of social media and communication tools for the promotion of online content, web platforms, websites and videos.
- Experience in the area of promotion of peace, tolerance and respect for diversity through communication tools;
- Experience in conducting workshops, training sessions, seminars for stakeholders and youth at community level;
- Experience in working with governments in Indonesia and the broader ASEAN region;
- Excellent written and verbal communication skills in English and Indonesian.

IV. PROPOSAL

<u>Proposed methodology, approach, quality assurance plan and implementation plan</u> – this section should demonstrate the NGO/CSO's response to the Terms of Reference by identifying the specific components of activities proposed, how the outputs/deliverables shall be addressed, as specified; providing a detailed description of the essential performance characteristics proposed; identifying the works/portions of the work that will be subcontracted.

Moreover, the proposal should demonstrate how the proposed methodology meets or exceeds the TOR, while ensuring appropriateness of the approach to the local conditions and the rest of the project operating environment. This methodology must be laid out in an implementation timetable and a quality assurance plan.

<u>Management Structure and Resource (Key Personnel)</u> – This section should include a comprehensive description of the management structure and information regarding required resources including curriculum vitae (CVs) of key personnel that will be assigned to support the implementation of the proposed methodology, clearly defining the roles and responsibilities vis-à-vis the proposed methodology. CVs should establish competence and demonstrate qualifications in areas relevant to the TOR.

Budget size and duration: Section To be completed -

Proposal amounts should be a maximum of **USD** *25,000* for all activities as stated in the ToR. The total amount quoted shall be all-inclusive and include all costs required to produce the deliverables identified in the TOR, including professional service fee, and any other applicable costs to be incurred by the contractor in completing the assignment. The contract price will be a fixed, output-based price regardless of any extension of the herein specified duration. It is suggested that the budget should follow approximate calculation:

The management cost should not exceed 20% of the total budget proposed. The amount requested in the proposal should be commensurate with the organization's administrative and financial management capabilities. In principle, project duration will not exceed two [2] months from November 2019 to December 2019.

Payment will be made upon the satisfactory delivery of outputs, as certified by Syamsul Tarigan, UNDP Indonesia, in consultation with UNDP BRH.

1. SELECTION PROCESS:

UNDP will review proposals through a five-step process: (i) determination of eligibility; (ii) technical review of eligible proposals; (iii) scoring and ranking of the eligible proposals based on the assessment criteria outlined in the previous section to identify the highest ranking proposal; (iv) round of clarification (if necessary) with the highest scored proposal; and (v) Micro-grant Agreement signature

Terms of Reference

NGO/CSO Support for Project Implementation in Indonesia Project: Preventing Violent Extremism through Promoting Tolerance and Respect for Diversity (PROTECT).

Background Information

South-East Asia has a long history of violent extremism, much of it based on a complex and often localized interaction between socio-economic and political contexts. However, from the Bali Bombings in 2002 to the Marawi siege that ended on the 23rd October 2017 killing over 1000 people and displacing 1.1 million, the growth of transnational terrorism has brought new violent extremism strategies, methods and risks to the region. In particular, it has opened local conflicts up to transnational forces, dynamics and increased the risks and destabilizing potential of localized extremist groups.

Indonesia, as the largest Muslim Population in the world, is not an exception. Since the early 2000s Indonesia has experienced the threat of terrorism and violent extremism. In January 2016 a major terrorist attack in the main street of Jakarta for which ISIS claimed responsibility killed four people and injured 23 others. Since then, there has been a continuous surge of terrorist attacks across Indonesia. In May 2018, Indonesia saw a series of suicide bomb in Surabaya and surrounding cities, killing 28 people and injuring 57 others.

In such a context of a growing threat of violent extremism in Indonesia and in South East Asia more broadly, UNDP has been implementing PVE project, called CONVEY (Countering Violent Extremism for Youth Project) since March 2017 in partnership with UIN-PPIM. To complement the ongoing project, UNDP has started to implement a project called "Preventing Violent Extremism through Promoting Tolerance and Respect for Diversity" or the PROTECT project. This project is a part of the regional PVE project and will be implemented in Indonesia with EU funding, channeling through UNDP Bangkok regional Hub. It will in particular build on the extensive experience of CONVEY Project.

The project's overarching goal is to contribute to reduce the vulnerability of Indonesia to violent extremism, reduce the danger of radicalization and increase the resilience of local communities and societies as a whole towards terrorist threats. The proposed objective(s) will be achieved by the following outputs through these activities and actions in Indonesia:

Output 1: Regional network of practitioners that conducts research, holds forums and develops policy recommendations for preventing violent extremism in Asia established

1. Commission research on gaps in knowledge on preventing violent extremism in South East Asia

Output 2: National Policies and programmes on violent extremism developed and implemented within a human rights and gender equality framework

- 2.1. A series of policy engagement measures that will ensure the National Action Plan (NAP) to be incorporated into the government's annual workplan and budget.
- 2.2. Series of Event to Accelerate the Issuance of National Action Plan on Prevention of Violent Extremism.

Output 3: Strengthened capacities of communities to promote peace, tolerance and respect for diversity

- 3.1. Create online and offline content of alternative narratives on prevention of violent extremism.
- 3.2. Conduct the workshop on "How to identify and response hate speech" and "How to create peaceful message on social media".
- 3.3. Arrange and conduct YouthCamp on PROTECTing Diversity.
- 3.4. Deliver the series of Festiversity (Festival of Diversity).

Regarding the component of offline and online activities for output 3, the UNDP will work closely with the selected CSOs in the following activities:

- 1. Conduct a series of video screening in promoting tolerance and diversity, in at least one (1) city in Sumatera, Java, Sulawesi and Maluku.
- 2. Deliver a series of activities as tools to promote tolerance and respect for diversity, in at least one (1) city in Sumatera, Java, Sulawesi, and Maluku

At the heart of the efforts to prevent violent extremism, one of objectives of the initiatives at PROTECT project is to promote the empowerment of youth to address the grievances and potential risks of radicalization. This sets the space for innovative programs of engagement and up-to-date activities that take into account the interests of young people. In this regard, spaces such as YouTube, Facebook, can offer powerful narratives to promote messages of peace and respect for diversity and information to not only counter extremist content, but to create new ideas and solutions to the various challenges confronting societies today. Technology companies such as Facebook, Instagram and YouTube have changed the dynamics of how people connect, communicate and relate to each other. These platforms are ideal for use by wide segments of the population and have a reach of influence not previously possible.

PROTECT Project in collaboration with INDIKA Foundation have been work with youth throughout Indonesia in promoting tolerance and respect for diversity through several activities, such as Workshop "Narasi Toleransi" covered three different theme on: (1) "How to identify and response hate speech"; (2) How to spread peaceful narratives (on social media); and (3) "How to be an influencing #KaptenToleransi", Festiversity (Festival of Diversity): "*Celoteh Toleransi*" to mark Indonesian Independence Day (17 August), YouthCamp: *Jelajah Toleransi* or the Exploration of tolerance, Festiversity: (Festival of Diversity): "*Simfoni Toleransi*" to mark the Oath of Youth Day (28 October) and peer-groups offline campaign under "*Aksi Toleransi*". During the activities under Output 3, UNDP Indonesia and Indika Foundation have produced possible several video documentaries and more than 500+ shareable contents to be spreads, made voluntarily by the participants.

During Workshop "*Narasi Toleransi*" the participants have made possible 5 (five) videos and under "*Jelajah Toleransi*", the participants have produced 10 (ten) videos during the journey or site-in exploration in 5 (five) cities: Ambon, Batu, Pangandaran, Poso and Wonosobo. The participants also worked collaboratively with KokBisa (an educational channel with the most subscibers on YouTube in Southeast Asia region) in producing 5 (five) educational videos on peace/ tolerance, and will be spread online through KokBisa's YouTube channel, starting from the first week of November 2019.

Considering that the contents of the videos produced are genuine and interesting, with the unique framing on youth's perspectives, ensuring the tolerance and diversity value are well integrated, the PROTECT project would like to spread those contents, through additional offline campaign, to more broader audience.

Scope of Work and Expected Results

The PROTECT project will be implemented through a mix of interventions by different stakeholders nationally.

Regarding the initiatives in the form offline activities, the selected NGO/CSO will focus its efforts on the following activities:

1. Conduct a series of video screening in promoting tolerance and diversity, in at least one (1) city in Sumatera, Java, Sulawesi and Maluku.

2. Deliver a series of activities as tools to promote tolerance and respect for diversity, in at least one (1) city in Sumatera, Java, Sulawesi, and Maluku

Institutional Arrangement

The selected NGO/CSO will work closely with focal points from UNDP Indonesia Country Office, government stakeholders, local partners and UNDP Bangkok Regional Hub. In addition, the selected NGO/CSO is responsible for the submission of the expected deliverables according to the above proposed timeline. Each deliverable must receive a technical clearance from UNDP in Indonesia, the Team Leader of the Democratic Governance and Poverty Reduction Unit (DGPRU) that is based in Jakarta.

The NGO/CSO is further expected to remain in close communications with DGPRU Project Coordinator for this project in providing regular updates through verbal or written communication. DGPRU will work with the NGO/CSO to ensure transparency and accountability of the micro-capital grant to be presented to the NGO/CSO. DGPRU expects the NGO/CSO to be responsive to UNDP requests that are aligned with the overall objectives of the project. Lastly, the NGO/CSO is expected to present reports, results, findings to various audiences as required/requested.

Duration of Assignment

The selected organization will undertake this assignment for 1 months, from November 2019 to December 2019.

Location of the Assignment

The selected organization will work in Jakarta and other areas of Indonesia, ensuring effective coordination and facilitation of activities. The identification and selection of area in which the offline campaign is targeted will be conducted collaboratively with local partners. The organization will be responsible to remain in regular communications with focal points from UNDP Indonesia Country Office and local partners.
