BACKGROUND

The two major disasters in 2018, earthquake, tsunami and liquefaction ravaged Central Sulawesi and West Nusa Tenggara (NTB). Particularly, the liquefaction affected Palu and caused approximately 10.000 people lost their homes. Hundreds of thousands of people lost their jobs and livelihood options. Disasters triggered by the earthquakes, tsunami and liquefaction caused substantive damage to community infrastructures, including buildings, roads, bridges, market facilities, irrigation canals, and drinking water schemes. The damaged infrastructures became almost non-operational, prompting the risk of migration for affected communities.

To accelerate rehabilitation and reconstruction process in both areas, UNDP is implementing the **Sulawesi / Lombok Programme for Earthquake and Tsunami Infrastructure Reconstructive Assistance (PETRA).** The goal of PETRA is to contribute to the rehabilitation and reconstruction of key infrastructure to support the resilient recovery of disaster-affected communities in both provinces. It addresses the need to accelerate the restoration of critical public services (such as health and education), improve economic livelihood opportunities for affected communities, while, at the same time, enhancing resilience to future shocks in both provinces. It will be guided and informed by the post-disaster needs assessments and will be fully aligned with relevant national and sub-national recovery plans. Beyond the immediate humanitarian and relief assistance, the KfW and UNDP has initiated engagements with national and local governments to support of Central Sulawesi and NTB's recovery efforts. Key government partners include BNPB, BAPPENAS, Ministry of Finance, Ministry of Public Works, the Provincial governments of Central Sulawesi and NTB, and the local governments of all ten districts and cities impacted by the disasters. PETRA will deliver two outputs, namely: (1) Rehabilitation and reconstruction of partially and fully damaged infrastructure for critical public services; and (2) Rehabilitation of affected communities' economic infrastructure to promote more resilient and sustainable livelihoods.

To ensure the PETRA project achieving its targets, monitoring the project implementation is a must. one among many others monitoring and oversight activity for such purpose is progress result tracking. To track PETRA progress result, it requires baseline data as stepping stone. Baseline data can be provided in quantitative and qualitative form. For example, baseline data in figures/numbers, written stories, also it can be presented in visual media such as documentary video.

Baseline Video can provide strong evidence that the changes provided since the disaster occurred. It is also worth a thousand words and may provide a short yet clear picture of how the PETRA project contributes to the recovery of affected communities in both targeted provinces. Therefore, a baseline video of both component 1 and 2 of PETRA needs to be produced before the ground work begins.

II. SCOPE OF SERVICES, EXPECTED OUTPUTS ANF TARGET COMPLETION

The implementation of baseline video production of UNDP PETRA project is part of the monitoring and evaluation of the project implementation and its results in supporting measuring the results and impact of PETRA project to the recovery of crisis-affected communities in Central Sulawesi and West Nusa Tenggara.

The expected results from this activity is a video of pre-intervention condition of targeted infrastructures for rehabilitation and reconstruction in 41 sites of Output 1 and 13 sites of Output 2 in both targeted provinces. Due to number of targeted sites, purposive sampling based on intervention's sector is suggested. Videos contain the baseline condition of each targeted infrastructures. Baseline condition means, the condition of targeted site before intervention PETRA project.

In pursuing the above-mentioned objective and expected results, the selected partner will be responsible to implement the following more detail sub-activities:

In addition to above expected outputs and activities, the selected partner obliges to prioritizing the participation of vulnerable and minority groups, such as women, youth, disable, and elderly it should be well identified and inclusively engaged in this video making process. Necessary support should be facilitated in order to ensure the participation of these groups in the activities, such as: consent letter and conducting discussion with potential key persons. Children protection should be put upfront in each activity, no children exploitation is allowed in this activity.

III. INSTITUTIONAL ARRANGEMENTS

The selected partner will work under direct supervision of UNDP Project Manager PETRA, and will be directly responsible for reporting findings, progress, issues and challenges, as well as to seek for acceptance and/or validation of milestones. Biweekly updates shall be furnished highlighting findings, issues, and progress of rehabilitation work, and monthly reports will be submitted to describe overall progress of the work. In day-to-day implementation, the selected partner will work in collaboration with the CRMEO PETRA.

Upon signing of the contract, the selected partner is expected to attend an inception meeting with UNDP to

review the scope of work, deliverables, site locations, reporting tools and formats and will agree those aspects.

A detail methodology and work plan, along with a schedule will be developed by the selected partner in consultation with UNDP. The work plan will be submitted for UNDP review and endorsement within 2 days following the inception meeting.

The selected partner will take full responsibility for the overall management of activities, and bears all substantive, operational, financial, monitoring responsibilities. UNDP will not provide any administrative support.

At the end of the assignment, the selected partner will have to submit a final report along with 6 baseline videos (4 videos for Output 1 and 2 videos for Output 2), with duration of 5-8 minutes per video.

V. GEOGRAPHIC AREA COVERAGE AND TARGET BENEFICIARIES

The baseline videos are expected to cover 5 sectors/sub in which are; landfill, hospital, puskesmas and pustu, and schools for component 1, and targeted community infrastructures in West Nusa Tenggara and Central Sulawesi targeted area. The geographic conditions of these areas are described as follow:

Central Sulawesi Area

1. Landfill Kawatuna (Output 1 - Palu)

This facility is located in Kawatuna-Palu Municipality. This is the only one landfill that exists in Palu. The Kawatuna landfill is one among many others public service facilities that impacted by a 28 September 2018 disaster. Based on Renaksi document of Palu Municipality, Kawatuna landfill categorized as heavily damaged infrastructures. Kawatuna played important role in waste management system of Palu Municipality. Therefore, the damaged of this infrastructure has significant impact to its capacity in handling the waste disposal and moreover it will also be impacting the surroundings environment negatively.

UNDP through PETRA project is planning to reconstruct Kawatuna Landfill as part of assisting Palu Municipality government in recovery post disaster.

PETRA project will reconstruct of; Leachate Treatment Plant; Rehabilitation of cell-2 Leachate Collection System; Reshaping, capping & closure of cell-2; Construction of cell-3 + Leachate Collection System; Landfill gas collection; Site drainage; Internal access roads; Perimeter fence and buffer zone; Operational office; Mechanical workshop; Security post; and Material Recovery Facilities (MRF).

Anutapura Hospital (Output 1 – Palu)

Anutapura hospital is located in Palu Municipality, the biggest public hospital in Palu. The Anutapura hospital was severely damaged by the 28 September 2018 earthquakes. As a consequence, it is unable to optimize in delivering health service to public of Palu.

Based on the technical assessment and after series of consultation meeting with national, local government and the hospital management, PETRA project will reconstruct, as follows:

- a. Murray (Stroke centre) building;
- b. Pharmacy store building;
- c. Electricity transformer.

3. SMKN I Sigi (Output 1 – Sigi)

SMKN I Sigi is located in Sidera village. Almost all of its buildings were collapsed and severely damaged by disaster, which caused difficulties in delivering education service to students. Since this school is a vocational school that is focusing on agriculture, based on initial survey of Geological Agency, half of its location is prone to liquefaction.

Targeted reconstruction for SMKN I Sigi are; Reconstruction of 28 classrooms; The main Hall; Practice room; Mechanical workshop; Warehouse; Science laboratory; Library; Computer laboratory; Language laboratory; Network laboratory; WASH facilities, and; Perimeter fence.

SMP N SATAP 3 Sindue Tobata (Output 1 – Donggala)

SMPN STAP 3 is located in Sindue Tobata. It is one of the junior high school for several villages that remotely located apart from sub district town center. All of its building was severely damaged by disaster, which caused difficulties in delivering education service to students.

Targeted reconstruction for SMPN SATAP 3 Sindue Tobata is; Reconstruction of 6 (six) classrooms; Science laboratory; WASH facilities, and; Perimeter fence.

5. SDN 21 Palu (Output 1 - Palu)

SDN 21 Palu is located in Palu Municipality. Most of its buildings were severely damaged by disaster, which caused difficulties in delivering education service to students.

Targeted reconstruction for SDN 21 Palu is; Reconstruction of 6 (six) classrooms; Teacher's office; Library; WASH facilities, and; Perimeter fence.

6. Puskemas Kulawi (Output 1 - Sigi)

Puskesmas Kulawi is located in the center of Kulawi subdistrict. Provided health services for villages within Kulawi area. This facility is played important role in providing health services to people of Kulawi due to geographical barriers. All of its building was severely damaged by disaster, which caused difficulties in delivering health service to community in need. Targeted reconstruction for Puskesmas Kulawi is reconstruction of the main building.

7. Tuva suspensions bridge (Output 2 - Sigi)

Tuva suspensions bridge played important role for Tuva community members, especially farmers because it connects Tuva villagers to their farm field across the Miu river. The earthquake followed by major floods few months later has caused damaged to the bridge. Consequently, Tuva's farmers have to take risk to reach their farm field by crossing the river. UNDP Petra is targeting to reconstruct the suspensions bridge to help community members accessing their farm field properly.

8. Education facilities in Parigi Moutong district (Output 1 - Parigi Moutong)

PETRA project is targeting to reconstruct seven (7) education facilities in Parigi Moutong district (5 elementary school and 2 Junior high school). Most of its buildings were severely damaged by disaster, which caused difficulties in delivering education service to students. Majority of targeted facilities for reconstruction work in those schools are classrooms, teacher's offices, and WASH facilities.

West Nusa Tenggara Area

Pustu Telaga Wareng-Lombok Utara (Output 1 - Lombok)

Pustu Telaga Wareng is located in Telaga Wareng village. This pustu operated 24/7 to provide health services to community of Telaga Wareng. However, due to the disaster, the Pustu building collapsed. The Pustu is still continuing its service using temporary building that is not fulfilling the health building standard. PETRA project will reconstruct Pustu Telaga Wareng along with 7 others Pustu in Lombok Utara district.

10. Puskesmas Labuan Induk – Lombok Timur (Output 1 - Lombok)

Puskesmas Labuan Induk is located in Lombok Timur. Its building collapsed due to August 2018 earthquake in Lombok. The Puskesmas is relocated to new location. PETRA project will build its main building.

11. SMK N I Pemenang (Output 1 - Lombok)

SMKN I Pemenang is one among other 4 other SMKN in Lombok Utara that are targeted by PETRA project to be reconstructed. Targeted reconstruction for SMKN I Pemenang are: Reconstruction of Classroom; Teacher's office; Laboratory; Practice room; Administration Office; and Perimeter fence.

12. Embung Genggelang (Output 2 - Lombok)

Embung (water pond) in Genggelang is played important role in providing clean water for Genggelang community members. However, due to the disaster that caused crack at the pond, water level has significantly decreased and as consequence clean water distribution to villagers disrupted. This condition enforced villagers to commute quite far to the river and other water sources to access for clean water. Some of them have to spend extra money for buying fresh water. PETRA project is planned to reconstruct this community infrastructure along with the village office and commodity kiosk to help the Genggelang community restore and recover their access to clean water, as well as to boost their economic activities.

Detailed list of targeted infrastructures of Output 1 of PETRA project is provided in Annex 4.

2. PAYMENT
