#### 3. Project Description

The UNDP CO in Armenia initiated this project to maximize its recovery efforts in response to the compound crisis in Armenia as a result of the COVID-19 and the recent hostilities in and around Nagorno Karabakh. Within the project UNDP will support the scale-up of technology-based solutions for faster recovery in the region of Syunik, as the most affected region in the country, with a key focus on primary health service delivery via digital technologies and green community lighting solutions.

The county has had the highest prevalence of the COVID-19 and is still grappling with the third wave of the virus with up to 500 cases daily. This stresses the healthcare system occasionally impairing its capacity to timely meet the needs of the most vulnerable population for regular check-ups, proper conditions for COVID-19 testing, or other laboratory services. The access issue is prevalent all over the country, yet the remote and bordering settlements of Syunik region show bigger vulnerability due to the security-related issues, which may constrain physical access to healthcare facilities. In cooperation with the national and local partners, UNDP pilots the mobile health service delivery model to facilitate the access to primary healthcare for the vulnerable groups with chronic health conditions, aged population, women, and children in the remote and rural areas. Next to being a part of the crisis response, the model is facilitating the e-governance in the healthcare system addressing the need for digital transformation catalysed by the COVID-19 and supports decentralisation of healthcare services.

As a result, one innovative mobile health care service will be piloted in Sisian enlarger municipalities (Syunik region) which has remote settlements, where there is no inter-settlement transportation, and the primary health care center(s) (ambulatoires) usually serve in average two settlements.
