1- Is it possible to submit reference letters on letterhead with signature and stamp via e-mail?

As indicated in Section 3, Terms of Reference, under Section H. Required Qualifications & Documentation from the Survey Company, page 34 & 36 1 successful original reference letter is required for LOT 2 & 3 & 4 & 5 & 6 and 3 successful original reference letters are required for LOT 1 both for UN and EU or other international projects as well as Government/Government Institutions. Accordingly, no e-mail reference letters will be accepted.

2- Is it possible to prepare 2 sets of notarized copies as such for LOT 1 and LOT 2 & 3 & 4 & 5 & 6? Or shall we prepare 6 separate notarized copies for each LOT?

As indicated in Section 3, Terms of Reference, under Section H. Required Qualifications & Documentation from the Survey Company, page 34 & 36; offerors are allowed to submit 2 sets of notarized copies as such; one set for LOT 1 and one set for LOT 2 & 3 & 4 & 5 & 6. Accordingly, if companies will submit proposals for all LOTs or for LOT 1 and any other combination from LOT 2 & 3 & 4 & 5 & 6, they are allowed to provide one original set for LOT 1 and one original set for LOT 2 & 3 & 4 & 5 & 6 by providing copy documentation in separate application envelopes as stamped 'SAME AS ORIGINAL' for all LOTs. The offerors should state clearly where the originals are placed.
