□ Ch II.2.1 : : It is mentioned in the TOR that "The structurals engineers are expected to conduct a field mission to Nothern Haîti including the following project sites : Cap-Haïtien , Fort Liberté , Port -de-Paix and Ouanaminthe". Shall the field mission include the North area of Haiti or be limited to the 4 cities Cap-Haïtien , Fort Liberté , Port -de-Paix et Ouanaminthe ?

## **Rep:** The northern Haiti corresponds to the departmental area of Cap-Haitian, Fort Liberté, Port -de-Paix and Ouanaminthe. Structural engineers field missions have to be focalized on the All the four capital cities of the North of Haiti.

□ Ch II.2.2 : : It is mentioned in the TOR that this work has to "Identify four to five typical building typologies that are representative of the project cities". Does the corresponding cities area is related to the core of the city of the whole area covered by the municipality.

ReP: Only the cities of cap Haitien(North department, port de paix (North west), fort liberte and ouanaminthe( North east) are concerned.

□ Ch II.3 of the TOR : Its is mentioned that available data for building inventory and population estimate has to be

reviewed. Please precise the available data for the project and the attempt of UNDP on this task.

Available Data will be collected from the ministry of interior and Ministry of Public work that each technical division has compiled some data.

□ Ch II.3.1 : Does a census of the population per neighborhood exist in each of the 4 cities

Ch II.3.3 It is mentioned in the TOR the digital data available for building inventory and population estimates must be considered. Please specify the data available for the project and UNDP attempt on this task.

The UND attempt on this task is to collect analyses and if necessary complete all these information and to organize them in GIS data-base,

□ Ch II.4 : It is mentioned in the TOR that seismic micro-zonation produced by BRGM data from ongoing studies have to be used in the project. Please confirm that these data will be available at the beginning of the project for each of the 4 cities under GIS form.

Yes these data are part of another UNDP funded project and will be available for cap Haitian and Ouanamithe in 2014 and fort liberte and Port de paix in the beginning of 2015.
