### **Addendum # 1**

#### **RFQ-UNDP/AFG/RFQ/2022/00000012222**

This addendum is issued with the purpose to amend **the above mentioned RFQ** as follows:

<b>Additional Requirements</b>	<p>The bidders are requested to further review the below additional requirements while submitting the quotation. All the requirements are mandatory and must be followed during the execution of the contract.</p> <p><b>Additional Requirements/Guidelines:</b></p> <p>The Contractor needs to provide health and safety emergency (HSE) plan which sets out the work steps, procedures, key risks and mitigation measures to UNDP representative prior of commencing the work.</p> <p>Contractor must compliance with UNDP rules and regulations and Afghanistan National Safety Standards, if a company is found to continually break the rules, this may lead to shutting down the work, and have contractual consequences, including cancellation of contract.</p> <p>The works include provision of all necessary materials, machineries, electrical generators including fuel consumption, tools, and laborers as mentioned in the BOQ.</p> <p>The Contractor is required to employ 100% laborers (where applicable) from the local community of the targeted areas.</p> <p>Selection process of workers: the contractor should announce publicly to register the name of people that apply for work from the local community. Then, the contractor should select the required number of workers through a transparent random selection process in the presence of UNDP and local community focal point.</p> <p>The contractor must ensure that the final list of selected workers is fitness to work and does not include people that are under the age of 18 years old, pregnant woman, addicted, close relatives and people from other areas."</p> <p>All the wages of the laborers and monitors shall be paid by the contractor on weekly bases and <b>daily wages of a 500 AFN per day minimum for eight hours of work per labor.</b></p> <p>The contractor shall coordinate with the security forces present in the area in order to secure the area of explosives, if any.</p>

	<p>The company is responsible for employing a Health and Safety Officer with intensive experience to oversee the safety measures and to ensure the safety of workers during the project's life cycle.</p> <p>The company is responsible to provide all the safety tools and equipment, such as helmets, masks, gloves for all workers (including provide and supply all the drivers of all the machineries), and work monitors, warning signs, warning tape and any other necessary tools to ensure the safety of workers, as well as a First Aid Kit at the work location, the providing of all the tools and equipment's mentioned above include replace and resupply all the worn out pieces during the work especially the safety shoes, helmets and masks for the workers.</p> <p><b><u>All interested bidders</u></b> are required to adhere to these additional guidelines.</p>
<b>Time Extension</b>	In order to prepare a comprehensive quotation, the deadline has been extended till 23 May 2022. The System Time as mentioned in the event will be followed.

**All other terms and conditions shall remain unchanged.**
