The exact coordinates of these Fishing Reserves will be given to the successful bidder by the Marine Conservation Division of the Albion Fisheries Research Centre. The average depth of all locations where buoys will be installed is about 4 metres.</p>

Or making use of Glass Reinforced Plastic (GRP) Board of 3.2mm in thickness with outstanding results both on national and international levels.</p>	<p>The signboard shall be of Aluminum Composite Panel (ACP) of 4 mm in thickness.
