1. BACKGROUND

United Nations Development Programme (UNDP) in Cambodia is looking for an Individual Contractor to perform the above mentioned assignment. Interested offeror is strongly advised to read the INDIVIDUAL CONSULTANT (IC) PROCUREMENT NOTICE for more detail about term of references, instructions to offeror, and documents to be included when submitting offeror.

2. SCOPE OF WORK, RESPONSIBILITIES AND DESCRIPTION OF THE PROPOSED ANALYTICAL WORK

4. FINANCIAL PROPOSAL

This is <u>Lump sum contracts</u>. Therefore, the interested offeror is requested to submit <u>Final All-Inclusive Price</u> with breakdown of costs.

5. EVALUATION

Offerors will be evaluated based on the Cumulative analysis.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilised in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the candidates who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

5. 1. Technical qualification evaluation criteria:

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification evaluation criteria:

Only the offeror/candidate who have attained a minimum of 70% of total points will be considered as technical qualified offeror/candidate.

5. 2. Financial/Price Proposal Comparison:

- Only the financial/price proposal of offeror/candidate who have attained a minimum of 70% score in the technical evaluation will be considered and evaluated.
- The total number of points allocated for the price component is 100.
- The maximum number of points will be allotted to the lowest price proposal that is opened/evaluated and compared among those technical qualified candidates who have attained a minimum of 70% score in the technical evaluation. All other price proposals will receive points in inverse proportion to the lowest price. [Lowest Price x 100 / Other Price under Consideration] = Points for Other Candidate's Price Component.

5.3. Selection Method and Award Criteria:

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

- Responsive/compliant/acceptable, and
- Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula: Total Score = Technical Score x 0.7 + Finance Score x 0.3

1. Project Description

The Royal Government of Cambodia's (RGC) commitment to improving the lives of people with disability through recognition of their rights was demonstrated through ratification of the Convention on the Rights of Persons with Disabilities (CRPD) in 2012 and launching it nationally together with the Incheon Strategy to "Make the Right Real" for Persons with Disabilities in 2013. The RGC have also enacted a number of disability laws and strategic plans in recent years, however, these are not fully aligned with the CRPD and implementation is weak. The RGC is conscious of the need to demonstrate real gains against its reporting obligations under the Convention and is actively requesting international assistance.

The long term goal of the Disability Rights Initiative-Cambodia (DRIC) Programme is the "improved quality of life for people with disability" in Cambodia. Achievement of the end-of-program outcome, ("People with disability have increased opportunities for participation in social, economic, cultural and political life through effective implementation of the National Disability Strategic Plan (NDSP)", will contribute to improve quality of life for people with disabilities.

The DRIC Programme is a broad initiative, funded by the Department of Foreign Affairs and Trade (DFAT) of the Australian Government, aiming to significantly enhance an enabling environment for persons with disabilities in Cambodia. The programme consists of the following four components:

- Supporting Government implementation of the Convention on the Rights of Persons with Disabilities (implemented by UNDP);
- Supporting Disabled People's Organisations to raise the voice and protect the rights of people with disability (implemented by UNDP);
- Supporting rehabilitation sector system strengthening (implemented by WHO);
- Inclusive governance and inclusive community development (implemented by UNICEF).

One of the challenges facing the RGC in implementing the CRPD and the Incheon Strategy is the lack of reliable data on disability, UNDP in close consultation with the National Institute of Statistics (NIS) and the Disability Action Council, is tasked to undertake a meta-analysis of available Cambodian disability data to make use of available evidence and to make recommendations for how to improve information relating to disability. The available data to be reviewed will include censuses, surveys and administrative data.

2. Scope of Work

The overall objective of the assignment is to identify, describe, analyse the available Cambodian data sets with regard to People with Disabilities and draw critical conclusions. This will require access to current data sets in Cambodia and disaggregating these where possible by type of disability, age, gender, ethnicity and identifying and analysing other factors that may be related to disability outcomes – such as socio-economic status (including income and educational level), size of household. It is anticipated the most recent Cambodia Socio Economic Survey (CSES) and the 2008 and 2013 Population Censuses, and Demographic and Health Survey will be among of these data sets.

On the basis of these results and bearing in mind other international approaches to data gathering in this area (e.g MICS, Washington Group, WHO Model Disability Survey) he/she will make recommendations for future disability data opportunities and approaches.

The national consultant is expected to provide:

- 1. Mapping and analysis of current available disability data sources with strengths and weaknesses for each data set considered.
- 2. Identification of the disability data gaps and needs in Cambodia, in relation to the RGC's commitments to report for CRPD, Incheon Strategy Indicators and WHO Global Disability Action Plan.
- 3. Recommendations for future actions to strengthen national capacities to collect reliable and internationally comparable disability data, through e.g. integrating disability into existing sources of data or designing a new data collection system/exercise, and the outline of a roadmap to achieve this by the end of the DRIC programme in 2018.

During the course of the assignment, the national consultant will also assist the programme in identifying the potential sources for fundraising to support the work to have more comprehensive disability data for Cambodia, including to conduct a nationally representative disability survey utilising the WHO Model Disability Survey Tool.

1. The national consultant will prepare a paper on the proposed analyses to be agreed with the joint programme team. On completion of the work the consultant will work closely with the international consultant to make a presentation on the final draft report to senior staff of the joint programme, including government officials, and will amend the report in the light of comments.

4. Institutional Arrangement

Under the overall guidance from the joint programme team and the direct supervision of the ACD and Governance Team Leader with guidance from the UN Joint Programme Coordinator, the national consultant on Disability Data Analysis will take responsibility for the data analysis and working closely with the international consultant for the production of the reports. Logistics support will be provided by the Joint Programme Coordination Unit.

The national consultant is expected to take initiative in identifying the available databases and at critical times to work closely with NIS, DAC and other relevant Ministries in order to gain access to detailed elements of the databases while at the same time respecting confidentiality and following necessary data access protocols.

5. Duration of the Work

The assignment will be 15 working days from August to October 2014. The national consultant is expected to be on board from 1st August and complete assignment not later than 30 October 2014. She/he has to submit the work plan prior the assignment.

The national consultant has to submit her/his outputs in accordance to the defined work plan and payment is issued only with satisfactory outputs accepted/approved by the joint programme team and UNDP ACD and Governance Team Leader.

All expected outputs could not be delay as result of assignment; therefore, the national consultant has to commit to deliver these outputs as planned.

6. Duty Station

The national consultant will be based in at UNDP Country Office. A driver along with a vehicle will be provided to support the consultant during the data collection and meetings with stakeholders.
