Maximum 1000 points will be given to the lowest financial offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. $Sf = 1000 \times Fm / F$, in which Sf is the financial score, Fm is the lowest price and F the price of the proposal under consideration.

The weight of technical points is 70% and financial points is 30% of the obtainable points

1) GENERAL BACKGROUND

Viet Nam is one of the world's ten most biologically diverse countries - it contains about ten percent of the worldwide species. Ecological systems together with their biodiversity are very important in Vietnam for sustainably local development for the wide array of goods and services they provide. However, biodiversity are under thread from different sources – including climate change. The unsustainable practices of economic development, rapid urbanization, shifting cultivation or expansion of arable land by encroaching into forest lands are, for example, among the most important causes leading to biodiversity loss.

Recognizing the importance of biodiversity conservation, the county has ratified/acceded to RAMSAR convention in 1989, UN Convention on Biodiversity in 1994, CITES in 1994, and Cartagena Protocol on Biosafety in 2004. It aims at protection and sustainable use of natural resources and its biodiversity.

Viet Nam's forest cover declined from 43% to 27% between 1943 and 1990. Since then, Viet Nam has made considerable efforts to increase its overall forest cover, which now stands at 13.39 million ha or 39.7%. The increase has been mainly due to new plantations, which account for 2.92 million ha.

Despite this increase, the quality of natural forests continues to decrease, suffering from fragmentation and degradation. Over two-thirds of Viet Nam's natural forests are considered poor or regenerating, while rich and closed-canopy forests constitute only 4.6% of the total. The area of natural forest classified as rich decreased by 10.2% between 1999 and 2005, and the amount of medium quality forest declined by 13.4%. Bio-diverse lowland forests have almost disappeared, and mostly remain in protected areas in particular mangroves. In line with this state of the forests, regeneration and restoration are highly relevant issues. Recent successes with forest plantations, and regeneration of secondary forests, suggest that there is considerable scope for enhancing carbon stocks across Viet Nam. However, natural forest regeneration is becoming more difficult due to the isolation of the remaining rich natural forest patches.

The factors driving deforestation/degradation have changed throughout the course of recent history. In the period 1943-1993, it was mostly a result of war and agricultural expansion by people migrating into

forested areas. Currently, the main direct causes of deforestation are generally agreed to be: (i) conversion to agriculture (particularly to industrial perennial crops); (ii) unsustainable logging (notably illegal logging); (iii) infrastructure development; and (iv) forest fires.

In response, the Government of Viet Nam (GoV) has launched a range of initiatives and reforms in the forestry sector. Overall, forestry continues to be guided by the *Central Communist Party Strategy for Industrialization and Modernizations, 2000-2020*, which identified five clear forestry objectives to be met by 2010: (i) increasing overall forest coverage to 43 % of the national land area; (ii) completing the allocation of forestry land to households and other entities; (iii) promoting forest-based livelihoods; (iv) protecting 10 million ha of natural forests through management contracts with smallholder households; and (v) accelerating the development of forest plantations. Forestry is also expected to play an enhanced role in alleviating poverty, with, for example, the *Viet Nam Forestry Development Strategy (VFDS) 2006-2020* placing considerable attention on land allocation and community forestry. In line with this, a series of policies, laws, institutional reforms, programmes, pilots and plans have been implemented over the last decade.

To assist the Government of Vietnam strengthening its policy and institutional framework on sustainable and community-based forest management, UNDP Vietnam Country Office, Sustainable Development Cluster (SDC) is looking a qualified international consultant to prepare a Project Identification Form (PIF) and support the Project Preparation Grant (PPG).

The proposed project will aim to support sustainable forest management in the highly bio-diverse central and mountainous regions of Viet Nam. It will focus on addressing some of the key elements of forest degradation and deforestation, forest resources management and degraded forest landscapes. It is expected to look at policy, legal, governance, enforcement and capacities aspects enabling sustainable forest management as well as mechanisms to enhance investment in SFM and restoration of ecosystem services provision. The PIF and PPG will be developed for eventual submission to the GEF Trust Fund.

2) OBJECTIVES OF THE ASSIGNMENT

The objective of this assignment is to finalize a PIF and a PPG request that focuses on mechanisms supporting sustainable forest management to sustain and enhance ecosystems services in the highly biodiverse central and mountainous regions of, Viet Nam.

The PIF and PPG should meet the requirements of GEF, UNDP and Government of Vietnam and related regulations/guidelines.

3) SCOPE OF WORK

The consultant will be responsible for the final delivery of the products (PIF and PPG) with the expected quality by UNDP and MARD.

The consultant will work very closely with MARD, Forest Inventory and Planning Institute and other experts from MARD, UNDP and forest institutions in Viet Nam to draft the PIF.

Based on the concept note developed by UNDP CO, specific tasks are as follows:

1.Leading technical oversight and guidance on PIF development:

- Review the barriers and gaps in the current policy, regulations, financial frameworks and programmes relating to sustainable forest management, forest restoration, biodiversity conservation and land management.
- Review the factors driving unsustainable forest management, biodiversity loss and land degradation in the proposed geographical areas for site selection (from Central Annamites Mountain Range, to Central Highlands and Central South Coast regions).
- Review GEF strategic policies/operational programmes relating to sustainable forest management, biodiversity conservation and land management.
- Review and synthesize baseline information associated to sustainable forest management policy and institutional frameworks and capacities in collaboration with experts.
- Discuss with UNDP SDC team and MARD to determine the scope, scale, and feasible implementation arrangement of the project. Taking into accounts all these aspect into a PIF.

2. Leading on project design in the PIF:

- Liaise with UNDP SDC team, GEF Vietnam (Operational Focal Point) and MARD to assess the status
 of sustainable and community-based forest management and enforcement in Vietnam and
 identify the options to reinforce the existing framework and build capacities for policy
 enforcement in the country.
- Refine and assess sustainability of the suggested project objectives, outcomes and outputs to meet with the GEF and UNDP criteria.
- Incorporate comments from all relevant national stakeholders, UNDP and GEF Secretariat into the final PIF for submission to GEF for approval.

3. PPG request

• Lead on the developing the PPG document with specific activities, budget and financing and tasks and consultants needed for PPG implementation.

Draft PIF and guidelines will be provided to the consultant upon signing the contract. During the period of PIF preparation, if technical discussions are required the consultant must be responsible for both organizing and facilitating the discussions.

The consultant must remain available for discussion and clarifications up to the final approval stage of the cycle.

4) DURATION OF ASSIGNMENT, DUTY STATION AND EXPECTED PLACES OF TRAVEL

Time effort for this assignment is about 12 working days. More details of work and detailed schedule will be developed and discussed with the Sustainable Development Cluster (SDC) in charge at the UNDP Country Office.

The consultant will be provided with all technical documents available on the subject as requested (if available).

The consultant will work from distance, with possible one visit (4 days) to Hanoi.
