1. BACKGROUND

UNDP is working with MONRE to support the National Strategy on Climate Change and the national Climate Change Committee through the "Capacity Building for Implementation of National Climate Change Strategy Project - CBICS". This Project aims to support the building of awareness, institutional, scientific and technical capacity for the effective implementation of the National Strategy on Climate Change (CC) at ministries and localities, making a contribution to the implementation of the Party Central Committee's Resolution NO 24-NQ/TW on actively responding to climate change, strengthening resource management and environmental protection. The project provides technical assistance, capacity development support, international experience sharing, and facilitation of evidence-based researches and participatory policy dialogues contributing to three outputs:

- (i) Improved institutional capacity for responding to CC by the National Committee on CC and focal points at relevant ministries and localities;
- (ii) Scientific and technical capacity will be strengthened for the development and implementation of adaptation and mitigation activities; and
- (iii) Awareness, and capacity of implementing responses to CC at Central agencies, localities and the community will be raised.

The National Strategy on Climate Change was approved by Prime Minister Decision 2139/QD-TTg (December 5, 2011) and emphasizes that climate change will impacts on all social aspects. For a country particularly vulnerable to the effects of climate change and sea level rise like Viet Nam, mainstreaming climate change into development plans of sector ministries, agencies and localities is one of the first priorities in responding to climate change.

The National Climate Change Committee (NCCC) is the main institutional mechanism for implementing the National Strategy on Climate Change. The NCCC reviews and suggests strategic directions and solutions regarding climate change interventions for the Government including on the mobilization, coordination and monitoring of resources to implement strategies and programmes on climate change.

The working group on climate change negotiation was established under Prime Minister Decision 80/QD-TTg dated 12 January 2012. The head of the working group is authorized to appoint its members based on proposals of different sectors/ministers (Decision 01/BCTDP dated 31 July 2013). This group is now fully operational; and engaged closely with the Conference of Parties (COP) to the UNFCCC.

During COP 19 in November 2013 in Warsaw it was agreed that all countries would specify their planned "Intended Nationally Determined Contributions" (INDCs) towards a new comprehensive global climate change agreement. At COP 20 in 2014 this was further specified in the "Lima Call for

Climate Action", which includes the following (text in bold highlight specific text regarding adaptation):

9. Reiterates its invitation to each Party to communicate to the secretariat its intended nationally determined contribution towards achieving the objective of the Convention as set out in its Article 2; 10. Agrees that each Party's intended nationally determined contribution towards achieving the objective of the Convention as set out in its Article 2 will represent a progression beyond the current undertaking of that Party;

[...]

- 12. *Invites* all Parties to consider communicating their undertakings in adaptation planning or consider including an adaptation component in their intended nationally determined contributions;
- 13. *Reiterates* its invitation to all Parties to communicate their intended nationally determined contributions well in advance of the twenty-first session of the Conference of the Parties (by the first quarter of 2015 by those Parties ready to do so) in a manner that facilitates the clarity, transparency and understanding of the intended nationally determined contributions;
- 14. Agrees that the information to be provided by Parties communicating their intended nationally determined contributions, in order to facilitate clarity, transparency and understanding, may include, as appropriate, inter alia, quantifiable information on the reference point (including, as appropriate, a base year), time frames and/or periods for implementation, scope and coverage, planning processes, assumptions and methodological approaches including those for estimating and accounting for anthropogenic greenhouse gas emissions and, as appropriate, removals, and how the Party considers that its intended nationally determined contribution is fair and ambitious, in light of its national circumstances, and how it contributes towards achieving the objective of the Convention as set out in its Article 2;

Under the leadership of Ministry of Natural Resources and Environment (MONRE), Viet Nam's INDC is being prepared jointly by the Ministry of Planning and Investment (MPI), Ministry of Finance (MOF), Ministry of Industry and Trade (MOIT), Ministry of Agriculture and Rural Development (MARD), Ministry of Transportation (MOT), Ministry of Construction (MOC), and Ministry of Science and Technology (MOST). UNDP and GIZ are providing technical support to Viet Nam's INDC preparation.

Viet Nam's INDC report will aim to provide a:

- National GHG inventory for 2005, 2010 and Estimated GHG emissions (CO₂, CH₄, N₂O) from major sources in 2020, 2030,
- Attain a better overview of potential GHG emission reduction as co-benefits in pursuing low carbon development partway, with consensus on targets, measures and policy options to reduce GHG emission while maintaining expected growth rate of socio-economic development;
- Identify clear gaps to enhance the country's climate resilience, and as follow up have achieved concurrence on priority actions and (sub-) sectors for climate change adaptations;
- Consider opportunities to mainstream climate change actions into socio-economic development planning, implementation and reporting, and enhance institutional capacity, coordination and financial allocation to enhance implementation of CC policies;
- Weigh options for, and uses of, fiscal policy instruments for addressing market failures, providing incentives, broadening the fiscal base and mobilizing revenues to catalyze investments into low carbon development.
- Secure a better position to support active participation and effective contribution to the international climate change negotiation;

Viet Nam currently intends to submit its consolidated INDC report in mid-2015, covering both adaptation and mitigation.

2. JUSTIFICATION

The INDC report should identify the needs of Viet Nam to ensure the country's sustainable development in the context of climate change, determining possible mitigation targets, adaptive measures and costs; and corresponding policy measures to enhance Viet Nam's climate resilience, low-carbon development, and contribution to the global efforts to respond to climate change. With regards to adaptation, the INDC submission should specifically:

- Assess potential impacts of climate change and vulnerability; identify loss and damage and select prioritized adaptation measures, in particular for the period after 2020;
- Identify financial and technological needs, as well as the national capacity building needs to
 effectively implement climate change policies which are integrated with the short-term and
 long-term socio-economic development strategies and plans (2020 2030);

While work is well underway for the climate change mitigation component of the INDC, work to assess adaptation components requires further effort in order to meet the Government's mid 2015 submission deadline.

This consultancy therefore aims to support the Government of Viet Nam INDC process to include analysis and data on climate change adaptation in its upcoming INDC report to the UNFCCC.

3. OBJECTIVE AND KEY ACTIVITIES

The objective of this consultancy is to:

Undertake a desk review of climate change impacts to identify adaptation needs and select optimal adaptation measures taking into account the special needs of delta, coastal and urban areas, with a focus on the post 2020 period, as a key contribution to Viet Nam's INDC drafting process.

The consultant will be expected to work as a part of a team comprising three national experts (2 sector specialists and one coordinator) to:

- Identify and analyze existing information on climate change impacts and adaptation studies for the selected sectors in Viet Nam.
- Review climate change impacts across sectors based on existing analysis and data.
- Differentiate, where feasible, climate change impact assessment by regions, including the Red river and Mekong river deltas, coastal regions and major cities;
- Propose adaptation options based on existing analysis and data.
- Estimate cost and to assess socio-economic and environmental benefits of the proposed adaptation options.
- Apply criteria to select adaptation options for the selected sectors.
- Assess the technology needs for the identified adaptation options.
- Assess the financial needs for the identified adaptation options.
- Evaluate capacity building needs for the identified adaptation options.
- Synthesize existing policies in Viet Nam and suggest policy development/ amendments/gaps to achieve identified adaptation targets.
- Develop a report identifying prioritized adaptation options for consideration by the Government of Viet Nam in the INDC formulation process (no more than 50 pages)

As part of this team the international consultant is specifically expected to:

- 1. Outline and refine with the team a methodology for identifying adaptation priority actions based on existing data that can be applied in drafting of the adaptation INDC process
- **2.** Provide examples of international good practice, and help guide concise and clear synthesis of data as a key team member of the drafting team
- **3.** Lead on a summary report on adaptation ready to be included in the INDC report of Viet Nam (no more than 3-5 pages) to synthesis overall findings and priorities

4. SCOPE

The International Consultant will work with a team of national consultants to produce the reports outlined above.

Given time and other constraints the review is intended to analyze, verify and interpret existing data contained in key existing documents such as the National Action Plan for Climate Change which lists prioritized adaptation actions with a focus on the period to 2020, the 2010 World Bank Study on the Economics of Adaptation to Climate Change Viet Nam case study, the draft *Viet Nam Special Report on Managing Risk of Extreme Events and Disasters to Advance Climate Change Adaptation (SREX – Viet Nam)* (2015), and other relevant documents.

The review should cover all sectors mentioned in NTP-RCC; National climate change strategy; National Climate Change Action Plan; sectoral climate change Action Plans, as well as selected provincial/municipal climate change Action Plans; and Viet Nam's Initial and Second National Communications as regards climate change impacts and adaptation priorities. Within this broader review, an emphasis should be placed on priority regions and priority sectors such as water resources, agriculture, forestry, aquaculture, selected infrastructure, and social aspects (including public health, education, and other social services).

The report should highlight what Viet Nam has already planned up to 2020, highlighting where funds have already been committed from the national budget and international support, and where further support from international partners may be required. It should however focus on identifying expected impacts and potential major losses and damages in the post 2020 period, and specifically the period 2020-2030; expected gaps and needs for technology, finance and further capacity building in that period; and proposed priority adaptation activities in that period. It should include a broad assessment, based on available studies and data, of the potential cost implications for Viet Nam of major early adaptation measures (including avoided future costs of climate change impacts as a result of early investments) as well as apparently unavoidable losses and damages in the post 2020 period.

5. METHODOLOGY

The International Consultant will be primarily responsible for helping define the methodology and approach and for data analysis and synthesis as part of the overall INDC process. This will include providing examples of international good practice where possible, and helping to guide concise and clear synthesis of data as a key team member of the drafting team. This will require close consultation and interaction with the national consultant teams and with other experts if required. The international consultant will also lead on drafting a summary report on adaptation ready to be included in the INDC report of Viet Nam (no more than 3-5 pages) to synthesis overall findings and priorities.

The National and International consultants will also be required to present at consultation meetings organized by MONRE on this topic as required.
