Annex 1: Terms of Reference/Specifications

REQUEST FOR QUOTATION (RFQ)

ICT Certifications Programme for Eligible Afghan Women/Girls

Background

UN Women, grounded in the vision of equality enshrined in the Charter of the United Nations, works for the elimination of discrimination against women and girls; the empowerment of women; and the achievement of equality between women and men as partners and beneficiaries of development, human rights, humanitarian action and peace and security.

In its efforts towards great gender equality in Afghanistan, UN Women wishes to provide scholarships for Afghan women and girls to obtain the Information and Communication Technology (ICT) certification in order to enjoy greater career prospects.

Description of ICT Certifications:

In this era of globalization, information and communication technology has created a world of no boundaries. Expertise and a good knowledge of ICT becomes a required skill in every field. The increasing need of ICT skills in the global world require individuals to prove that they excel and have the competency in ICT. Therefore, it is a vital requirement for Afghan girls and women working in this field to have an internationally standardized ICT certificate in order to advance their career. The certificates covered are the following:

- Microsoft Certified Professional (MCP)
- Microsoft Certified System Associate 2012 (MCSA).
 - o MCSA: Windows Server 2012
 - o MCSA: Windows 8
- Microsoft Certified System Engineer 2012 (MCSE).
 - MCSE: Server Infrastructure
 - MCSE: Desktop Infrastructure
 - MCSE: Communication
- Microsoft Exchange 2010 (MCITP)
- Internetworking of Content Delivery Networks (ICDN) 1
- Internetworking of Content Delivery Networks (ICDN) 2
- Cisco Certified Network Associate, R&S (CCNA)
- Cisco Certified Network Professional, R&S (CCNP)

Objectives

The objective of this scholarship is to provide eligible Afghan women and girls, selected by UN Women, to obtain the ICT certification in order to enjoy better career prospects in the field of Information Communication Technology and prosper in their field of work.

Assignment

UN Women seeks the services of an experienced University, Higher Education Institute, Training Consultancy Firms or Training Centers with certified trainers with at least 5 years of teaching experience in the mentioned certification Programmes and preferably be Microsoft Certification Partner, Microsoft Training Partner, Cisco Learning Partner and have Microsoft and

Cisco Certified Trainers and be able to offer the ICT certification classes for female candidates towards preparing them for the ICT certification tests and to facilitate their examination at a Microsoft/Cisco Official Online Test Center. Preference will be given to companies that are the authorized testing partners for the relevant certifications.

The quality of the training classes should ensure at least 80% success rate in the women attempting the ICT certification exams.

Teaching methodology should be practical, which means each class should be equipped with real devices (routers/switches/servers) including the individual rack.

Scope of work

The selected institution will complete the following tasks in close consultation with UN Women Afghanistan Country Office:

Selection of Students:

- Assist UN Women in facilitating the admission exam to the students, as requested by UN Women
- Assist UN Women in reviewing the admission test examination paper of the students as requested by UN Women

Organization of classes:

- Provide the Microsoft/Cisco Training Materials (Books, Kits and References) related to the ICT certifications, as well handouts and PowerPoint presentation to all students.
- Classes should be facilitated by certified facilitators.
- Training facilities (comfortable classrooms/workshops/practical lab work), materials and equipment should be used.
- Conduct the classes on a consistent and regular manner on the working days.
 Determining of class hours should be flexible and mutually decided by UN Women and the contractor company.
- Maintain the attendance sheet of the students on a daily basis.

Facilitating the Examination Process:

- Facilitate mock testing to ensure the students are prepared to attempt the ICT certification examinations and report to UN Women on the status of preparation of the students for attempting the exams before they are cleared for the examination.
- It is preferred that the applicant company is a Official Microsoft/Cisco Certification Test Center in Kabul. However, the applicant company may also propose facilitating the test outside the country, indicating in the proposal the country and the testing center selected for this purpose.
- Book seats for examinations for all the students and facilitate the test.
- Share the test results with UN Women.
- In the scenario that the test will be arranged outside Afghanistan, the company will be responsible to:
 - Facilitate the visa application process for the candidates
 - Purchase air tickets for the candidates

 Provide suitable accommodation and cover the stay expenses of the students in the targeted country for examination

Deliverables

Phase I:

 A clear workplan and standard curriculum towards completion of the ICT Certifications training and examination, including dates, venues, and facilitator's details. Material handouts and presentation to be provided by the company.

Phase II:

Regular attendance sheet of the students

Phase III:

Organization of the training Programme as per the agreed curriculum and work plan.

Phase IV:

Facilitation of the test for all the students to take the standard examination.

Duration of assignment

The proposal should indicate clearly the duration required for completion of each certificate.

Application

Submit your technical and financial offer for the ICT Certification Programmes:

Technical proposal should include:

- a) Brief information about your firm including past experience on providing Microsoft/Cisco Certification and the passing rate of the students.
- b) CVs of Trainers who will conduct the proposed programme
- c) Methodology and approach
- d) Draft outline of the curriculum for Each Certification and Exam Papers.

Financial proposal should include:

The financial proposal shall specify a lump sum cost for each certificate separately, including the costs of the training, material, facilities, final official testing as well as any associated travel cost if applicable. The proposed budget should include all costs, for planning phase, conducting the classes as well as the online official examinations.

The financial proposal should consider 5-10 students for each certification; however, depending on the flow of applications, the number could change up to 50% percent increase or decrease in each category.

Evaluation

Offers will be evaluated based on lowest price among the technically compliant offers. When using this method, the award of a contract should be made to the firm whose offer has been evaluated and determined as both:

- a) responsive/compliant/acceptable, and
- b) Offering the lowest price/cost

[&]quot;responsive/compliant/acceptable" are defined as fully meeting the TOR provided.
