A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e.  $Sf = 1000 \times Fm / F$ , in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

Interview with the candidates may be held if deemed necessary.

# 1) GENERAL BACKGROUND

The UN-REDD Viet Nam Phase II Programme is a part of the United Nations Collaborative initiative on Reducing Emissions from Deforestation and forest Degradation (UN-REDD). The Vietnam Administration of Forestry (VNFOREST) under the Ministry of Agriculture and Rural Development (MARD) is the Programme Owner. The Phase II Programme runs from mid-2013 to end-2015 and benefits from the support of the Food and Agriculture Organization of the United Nations (FAO), the United Nations Development Programme (UNDP) and the United Nations Environment Programme (UNEP).

Phase II of the Programme will assist Viet Nam to implement the National REDD+ Action Programme (NRAP). The overall objective is "to enhance Viet Nam's ability to benefit from future results-based payments<sup>1</sup> for REDD+ and undertake transformational changes in the forestry sector". This Objective will be secured through the following six Outcomes:

- Outcome 1: Capacities for an operational National REDD+ Action Programme (NRAP) are in place
- Outcome 2: The six pilot provinces are enabled to plan and implement REDD+ actions
- Outcome 3: National Forest Monitoring System (NFMS) for Monitoring and Measurement, Reporting and Verification and National REDD+ Information System (NRIS) on Safeguards are operational
- Outcome 4: Stakeholders at different levels are able to receive positive incentives
- Outcome 5: Mechanisms to address the social and environmental safeguards under the Cancun Agreement are established
- Outcome 6: Regional cooperation enhances progress on REDD+ implementation in the Lower Mekong Sub-Region

VNFOREST has established the UN-REDD Programme Management Unit (PMU) to implement the Phase II Programme under the leadership of the National Programme Director (NPD), assisted by a deputy NPD, and a National Programme Coordinator.

The six pilot provinces are: Lam Dong, Bac Kan, Ha Tinh, Binh Thuan, Ca Mau and Lao Cai. In these provinces, the Phase II Programme will support preparation and initial implementation of Provincial REDD+ Action Plans (PRAP).

#### 2) BACKGROUND TO THE ASSIGNMENT

# **UNFCCC** requirements on REDD+ safeguards:

The Cancun Agreements<sup>2</sup> (Decision 1/CP. 16), of the United Nations Framework Convention on Climate Change (UNFCCC), calls countries who will implement REDD+ to address and respect seven broad

safeguards related to governance, social and environmental risks and benefits, as well as emission reductions risks. In addition, the Durban Outcome<sup>3</sup> (Decision 12/CP.17) states that a Safeguards Information System (SIS) should provide information on how all Cancun safeguards are addressed and respected. This was reiterated by the Warsaw Framework<sup>4</sup> for REDD+ (Decision 9/CP.19), that requires countries to submit, among others, summary of information on how all the safeguards have been addresses and respected before they can receive results-based financing. (See Annex 1 for a reproduction of all safeguards-relevant decisions made under the UNFCCC).

**Country approach to safeguards**: The UN-REDD Programme promotes <u>a country approach to safeguards</u>, which builds on a country's *existing* governance arrangements to meet UNFCCC requirements (see Figure 1).

These governance arrangements can be broken down into three core components:

1. Policies, laws and regulations (PLRs), which define, on paper, what needs to be done in order to support implementation of REDD+ actions in a manner consistent with Cancun (and other) safeguards, i.e. how safeguards are being addressed. PLRs are primarily codified statutory ordinance, but countries may also consider to include corporate environmental and social responsibility policies, industry standards and customary norms of indigenous peoples and local communities.

- 2. Institutional arrangements their mandates, procedures and capacities to ensure that the relevant PLRs are actually implemented in practice, i.e. how safeguards are being respected. Such arrangements are typically institutionalised within public, private or civil society sectors, but may also involve arrangements to strengthen the individual capacities of citizens, including indigenous peoples and local communities, to implement and enforce relevant PLRs.
- 3. *Information systems*, which collect and make available information on how REDD+ safeguards are being addressed and respected throughout REDD+ implementation.

In addition to responding to UNFCCC requirements, a country approach to safeguards allows countries to consider further objectives, such as their own domestic sustainable development and green growth policy goals, other international policy commitments, as well as responding to the requirements of organizations providing interim results-based payments for REDD+ activities.

Country safeguard approaches can build extensively on existing national PLRs, government and non-government institutions to implement these PLRs, as well as systems for collecting and reporting information.

**Safeguards work in Viet Nam:** Previous work on REDD+ safeguards was led by VRO/DOSTIC as focal point for REDD+ in Viet Nam. The sub-technical working group on safeguards (STWG-SG) was established in 2012 as platform for discussion and broad national level consultations (documentation can be found in <a href="http://www.vietnam-redd.org/Web/Default.aspx?tab=news&zoneid=108&subzone=113&child=209&lang=en-US">http://www.vietnam-redd.org/Web/Default.aspx?tab=news&zoneid=108&subzone=113&child=209&lang=en-US</a>).

The major piece of work on REDD+ safeguards to date has been the development of a 'Safeguards Roadmap' for the NRAP, and which outlined the country-led approach to REDD+ safeguards. The roadmap also included a review of existing PLRs which demonstrate on paper how Viet Nam could address the Cancun safeguards (see green boxes in Figure 1 above) and identified corresponding gaps in the existing PLR framework against a generic international legal best practice interpretation of the Cancun safeguards. The logical next step is, therefore, to assess the institutional framework and capacity in place to implement and enforce Vietnam's existing legal framework, and its functionality in practice.

The Strategic Environmental and Social Assessment (SESA) under the World Bank's Forest Carbon Partnership Facility (FCPF) in Viet Nam will predominantly analyse *national* level PLRs and institutional arrangements, in relation to NRAP, through consultation with key national stakeholders. There may be similar consultations with provincial stakeholders in the six provinces<sup>5</sup> of Viet Nam's proposed <u>Emissions Reduction Program for the FCPF Carbon Fund</u> in the North-Central Agro-Ecological zone. The SESA process will culminate in the development of an Environmental and Social Management Framework (ESMF) for the proposed Emissions Reduction Program landscape.

To complement the national analysis by FCPF, this UN-REDD Programme assessment of institutional capacity to implement PLRs relevant to REDD+ safeguards will begin by focusing at the *provincial* level, particularly provinces with completed or on-going Provincial REDD+ Action Plans (PRAP). Where relevant, and when appropriate, assessments may also be extended to the *national* level.

Both this assessment and the SESA at the national level are expected to assist Viet Nam in demonstrating how the Cancun (and, in the case of the SESA, the World Bank) safeguards are being respected, i.e. how safeguard-relevant PLRs are being implemented in practice and what are the environmental and social outcomes of these practices.

Lastly, in parallel to this assignment on capacities to implement PLRs, the UN-REDD Programme (UNEP technical lead) will also be supporting the development of Viet Nam's SIS (see purple boxes in Figure 1). The (consultative, multi-stakeholder) SIS development process, will comprise determining objectives, scope and design options, as well as institutional arrangements, information content and structure, and technological dissemination solutions for the SIS. In addition to close coordination with the FCPF SESA process, the assignment outlined in these ToR will also need to engage, and benefit from mutual exchange, with that on SIS development.

**Safeguards under UN-REDD Programme (Outcome 5):** The core focal areas of Programme support under Outcome 5 are: (1) goal, scope and process of country safeguards approach defined and safeguards information system (SIS) determined and (2) policies and measures to ensure that safeguards concerns are being addressed and respected.

# 3) OBJECTIVE & SCOPE OF THE ASSIGNMENT

The key objective of this assignment is to ensure Viet Nam has identified the necessary institutional mandates, procedures and capacities, to implement the relevant policies, laws and regulations, as significant contribution to respecting the Cancun safeguards for REDD+ of the UNFCCC.

To achieve the objective, this assignment intends:

- (i) to clarify the scope of REDD+ policies and measures at the provincial level in relation to drivers of deforestation and forest degradation analyses and other information sources;
- (ii) to preliminarily scope the potential environmental and social benefits and risks associated with proposed REDD+ policies and measures;
- (iii) to identify existing institutions and institutional mandates, procedures and capacities to implement the relevant PLRs, which address the potential environmental and social benefits and risks associated with anticipated REDD+ policies and measures;
- (iv) to recommend measures to strengthen the implementation of priority PLRs, which operationalise the Cancun safeguards, in relation to anticipated REDD+ policies and measures at the provincial level.
- (v) to recommend refinements to candidate PRAP (and possible NRAP) policies and measures to make them more environmentally sound and socially equitable in their selection, design and location
- (vi) to recommend immediate capacity needs of provincial institutions to inform capacity development interventions under UN-REDD Viet Nam Phase II Programme, Output 5.2. in 2016.

In performing the services for this assignment, the team will need to assess the implementation of the most relevant PLRs<sup>6</sup>, which address the Cancun safeguards, with respect to identified or anticipated environmental and social benefits and risks of provincial REDD+ policies and measures. This will focus on a review of existing institutional framework, mandates, procedures and capacities to implement the identified priority PLRs. REDD+ policies and measures will be identified in relevant Provincial REDD+ Action Plans (PRAPs), and the Emission Reduction- Project Idea Note (ER-PIN) in the case of Ha Tinh province.

The consulting team will work mainly under the supervision of National Project Director (NPD), and/or the Deputy NPD (DNPD), who takes the overall lead for the UN-REDD Phase II Programme implementation. The team will be based at PMU, and will report to the NPD and/or DNPD and UNDP Viet Nam. As mentioned above however, it will be necessary to cross-reference and discuss findings from the assessment with those of other assessments and initiatives addressing REDD+ safeguards, especially the SESA. It is important for the team to augment their own analysis and assessment with findings from other studies past and on-going. Therefore, the STWG on REDD+ Safeguards will provide a crucial forum for ensuring coherent coordination, and for the team to consult with other key stakeholders, consultants/advisers to ensure the highest possible quality and validity of the outputs. Findings from this assessment should contribute to the articulation of a national SIS. This assessment should also build on, and integrate with, the on-going development of grievance redress mechanism(s) for REDD+.

Recommendations on how to strengthen the implementation of priority PLRs (respecting safeguards) will be presented to VNFOREST, and other national stakeholders, working closely with the STWG on REDD+ Safeguards, Forest Protection Department (FPD) and Viet Nam REDD+ Office (VRO). These recommendations will then subsequently inform the refinement of interventions under UN-REDD Phase II Programme's Output 5.2 - PLRs to address and respect REDD+ safeguards operationalized.

# 4) TEAM COMPOSITION & TASKS ASSIGNED

In order to adequately address the objectives and scope of the assignment, it is necessary that the team is comprised of specialists with complementary specialisms covering the different types of safeguard issues highlighted in the Cancun text (i.e. governance, social and biodiversity/environmental safeguards). All team members should be familiar with the REDD+ context in Vietnam as well as the main PLRs of relevance (in their respective areas of specialisation) to REDD+ safeguards operationalisation in Vietnam.

# Team leader (One international consultant): 35 days

- Lead development of methodology and joint work plan for the team across all tasks below.
- Ensure good coordination and consultation with relevant partners (especially through the STWG on REDD+ Safeguards) and work areas of the UN-REDD Programme (Forest Reference Emission Level scope; PRAP development; SIS design; Grievance Redress Mechanism assessment, etc.)
- Work closely with the core group of the STWG on REDD+ safeguards and the FCPF SESA team to ensure coherent analysis of PLRs and institutional gaps and/or to clearly frame any discrepancies which may arise between the two technical expert assessments.

- As necessary, develop questionnaires or other tools for data collection and consultation with team members and others.
- Lead and take part in field work, if necessary.
- Lead development and finalize the report to ensure the quality of work for submission.

# Team members (Two national consultants): Total of 90 days; 45 days per consultant

- Discuss joint work plan.
- Facilitate consultation.
- Provide comments on methodologies, questionnaires and data collection tools.
- Lead and take part in the field work.
- Contribute to the report.

The team will jointly conduct the following specific tasks:

# A. Desk Review and Action Plan (International and national consultants)

- 1. Review relevant international and national documentation related to the country approach to safeguards and progress on safeguards work within Viet Nam and the wider region to date;
- Review emerging findings and recommendations from related on-going UN-REDD assignments such
  as FREL scope; provincial drivers/barriers assessments; PRAP development; the development of
  SIS; GRM assessment; as well as other safeguard-relevant initiatives such as FCPF SESA-ESMF;
  Clarify the scope of provincial REDD+ policies and measures in Viet Nam that would need to be
  safeguarded through application and implementation of relevant existing national PLRs;
- 3. Develop systematic methods to assess institutional mandates, processes and procedures, and existing capacities to implement priority PLRs, such as determine performance criteria or indicators or equivalent to assess the implementation of PLRs
- 4. Develop a work plan that stipulates consultation with key stakeholder groups and includes:
  - o Clear timeline, methods, steps, detailed activities;
  - List of stakeholders to be consulted; and
  - Estimated budget for activities developed in consultation with NPD and/or DNPD, and UNDP Viet Nam.

# B. Assess the institutional capacity to implement the most relevant PLRs with respect to anticipated policies and measures

- 1) Evaluate existing (where available<sup>7</sup>), and conduct preliminary novel (where not), environmental and social benefit and risk assessments of provincial policies and measures identified to address underlying causes of drivers and barriers in Vietnam<sup>8</sup>\*;
- 2) Identify the PLRs, from the 60 PLRs assessed under the Safeguards Roadmap v2.0, and new PLRs not previously included in the Safeguards Roadmap v2.0, which are most relevant to the potential environmental and social benefits and risks of candidate REDD+ policies and measures<sup>9</sup> at the provincial level\*;
- 3) Identify and review relevant institutions<sup>10</sup>, their mandates, processes and procedures, and existing capacities at appropriate levels to implement priority PLRs in respecting the Cancun safeguards;
- 4) Iteratively soliciting stakeholder feedback on assessment findings through a variety of methods, such as provincial and national consultation workshops, key informant interviews and draft report review.\*
- 5) Incorporate stakeholder feedback on findings and recommendations in a revised final report documenting: i) potential environmental and social risks and benefits of PRAP policies and measures; ii) strengthened PLR implementation arrangements to mitigate those risks/maximise benefits; iii) refinements to candidate PRAP (and possible NRAP) policies and measures to make them more environmentally sound and socially equitable in their selection, design and location; and

iv) immediate capacity needs of provincial institutions to inform capacity development interventions under UN-REDD Viet Nam Phase II Programme, Output 5.2. in 2016.

# 5) DURATION OF ASSIGNMENT, DUTY STATION AND EXPECTED PLACES OF TRAVEL

Duration: Estimated 125 person-days in total for 3 consultants between August to December 2015.

# Annex 1a: Relevant UNFCCC Decisions on Safeguards

#### Decision 1/CP.16 (Cancun, 2010)

- 69. Affirms that the implementation of the activities referred to in paragraph 70 below should be carried out in accordance with annex I to this decision, and that the safeguards referred to in paragraph 2 of annex I to this decision should be promoted and supported;
- 71. Requests developing country Parties aiming to undertake the activities referred to in paragraph 70 above, in the context of the provision of adequate and predictable support, including financial resources and technical and technological support to developing country Parties, in accordance with national circumstances and respective capabilities, to develop the following elements:
  - A system for providing information on how the safeguards referred to in appendix I to this decision are being addressed and respected throughout the implementation of the activities referred to in paragraph 70 above, while respecting sovereignty;
- 72. Also requests developing country Parties, when developing and implementing their national strategies or action plans, to address, inter alia, the drivers of deforestation and forest degradation, land tenure issues, forest governance issues, gender considerations and the safeguards identified in paragraph 2 of appendix I to this decision, ensuring the full and effective participation of relevant stakeholders, inter alia indigenous peoples and local communities;
- 76. *Urges* Parties, in particular developed country Parties, to support, through multilateral and bilateral channels, the development of national strategies or action plans, policies and measures and capacity-building, followed by the implementation of national policies and measures and national strategies or action plans that could involve further capacity-building, technology development and transfer and results-based demonstration activities, including consideration of the safeguards referred to in paragraph 2 of appendix I to this decision, taking into account the relevant provisions on finance including those relating to reporting on support;

#### Appendix 2 [the 'Cancun safeguards]

- 2. When undertaking the activities referred to in paragraph 70 of this decision, the following safeguards should be promoted and supported:
  - a) That actions complement or are consistent with the objectives of national forest programmes and relevant international conventions and agreements:
  - b) Transparent and effective national forest governance structures, taking into account national legislation and sovereignty;
  - Respect for the knowledge and rights of indigenous peoples and members of local communities, by taking into account relevant international obligations, national circumstances and laws, and noting that the United Nations General Assembly has adopted the United Nations Declaration on the Rights of Indigenous Peoples;
  - d) The full and effective participation of relevant stakeholders, in particular indigenous peoples and local communities, in the actions referred to in paragraphs 70 and 72 of this decision;
  - e) That actions are consistent with the conservation of natural forests and biological diversity, ensuring that the actions referred to in paragraph 70 of this decision are not used for the conversion of natural forests, but are instead used to incentivize the protection and conservation of natural forests and their ecosystem services, and to enhance other social and environmental benefits;
  - f) Actions to address the risks of reversals;
  - g) Actions to reduce displacement of emissions.

#### Decision 12/CP.17 (Durban, 2011)

Preamble: *Noting* that guidance on systems for providing information on how safeguards referred to in appendix I to decision 1/CP.16 are addressed and respected should be consistent with national sovereignty, national legislation and national circumstances,

- I. Guidance on systems for providing information on how safeguards are addressed and respected
- 1. Notes that the implementation of the safeguards referred to in appendix I to decision 1/CP.16, and information on how these safeguards are being addressed and respected, should support national strategies or

action plans and be included in, where appropriate, all phases of implementation referred to in decision 1/CP.16, paragraph 73, of the activities referred to in paragraph 70 of the same decision;

- 2. Agrees that systems for providing information on how the safeguards referred to in appendix I to decision 1/CP.16 are addressed and respected should, taking into account national circumstances and respective capabilities, and recognizing national sovereignty and legislation, and relevant international obligations and agreements, and respecting gender considerations:
  - a) Be consistent with the guidance identified in decision 1/CP.16, appendix I, paragraph 1;
  - b) Provide transparent and consistent information that is accessible by all relevant stakeholders and updated on a regular basis;
  - c) Be transparent and flexible to allow for improvements over time;
  - d) Provide information on how all of the safeguards referred to in appendix I to decision 1/CP.16 are being addressed and respected;
  - e) Be country-driven and implemented at the national level;
  - f) Build upon existing systems, as appropriate.
- 3. Agrees also that developing country Parties undertaking the activities referred to in decision 1/CP.16, paragraph 70, should provide a summary of information on how all of the safeguards referred to in decision 1/CP.16, appendix I, are being addressed and respected throughout the implementation of the activities;
- 4. Decides that the summary of information referred to in paragraph 3 above should be provided periodically and be included in national communications, consistent with relevant decisions of the Conference of the Parties on guidelines on national communications from Parties not included in Annex I to the Convention, or communication channels agreed by the Conference of the Parties;
- 5. Requests the Subsidiary Body for Scientific and Technological Advice, at its thirty-sixth session, to consider the timing of the first presentation and the frequency of subsequent presentations of the summary of information referred to in paragraph 3 above, with a view to recommending a decision on this matter for adoption by the Conference of the Parties at its eighteenth session;
- 6. Also requests the Subsidiary Body for Scientific and Technological Advice, at its thirty-sixth session, to consider the need for further guidance to ensure transparency, consistency, comprehensiveness and effectiveness when informing on how all safeguards are addressed and respected and, if appropriate, to consider additional guidance, and to report to the Conference of the Parties at its eighteenth session;

#### Decision 9/CP.19 (Warsaw, 2013)

- 4. Agrees that developing countries seeking to obtain and receive results-based payments in accordance with decision 2/CP.17, paragraph 64, should provide the most recent summary of information on how all of the safeguards referred to in decision 1/CP.16, appendix I, paragraph 2, have been addressed and respected before they can receive results-based payments;
- 11. *Decides* that the information hub will contain, as reported through the appropriate channels under the Convention:
  - c) The summary of information on how all of the safeguards referred to in decision 1/CP.16, appendix I, are being addressed and respected, as referred to in decisions -/CP.199 and 12/CP.17, chapter I;

#### Decision 12/CP.19 (Warsaw, 2013)

The timing and the frequency of presentations of the summary of information on how all the safeguards referred to in decision 1/CP.16, appendix I, are being addressed and respected

The Conference of the Parties,

Recalling decisions 17/CP.8, 1/CP.16, 2/CP.17 and 12/CP.17,

Also recalling, in particular, decision 12/CP.17, paragraph 5,

- 1. Reiterates that according to decision 12/CP.17, paragraph 3, developing country Parties undertaking the activities referred to in decision 1/CP.16, paragraph 70, should provide a summary of information on how all of the safeguards referred to in decision 1/CP.16, appendix I, are being addressed and respected throughout the implementation of the activities;
- 2. Also reiterates that according to decision 12/CP.17, paragraph 4, the summary of information referred to in paragraph 1 above should be provided periodically and be included in national communications, or communication channels agreed by the Conference of the Parties;

- 3. Agrees that the summary of information referred to in paragraph 1 above could also be provided, on a voluntary basis, via the web platform on the UNFCCC website;
- 4. *Decides* that developing country Parties should start providing the summary of information referred to in paragraph 1 above in their national communication or communication channel, including via the web platform of the UNFCCC, taking into account paragraph 3 above, after the start of the implementation of activities referred to in decision 1/CP.16, paragraph 70;
- 5. Also decides that the frequency of subsequent presentations of the summary of information as referred to in paragraph 2 above should be consistent with the provisions for submissions of national communications from Parties not included in Annex I to the Convention and, on a voluntary basis, via the web platform on the UNFCCC website.
