4. FINANCIAL PROPOSAL

This is <u>Lump sum contracts</u>. Therefore, the interested offeror is requested to submit <u>Final All-</u> <u>Inclusive Price</u> with breakdown of costs.

¹ RLA is an instrument used to engage individuals that are employed with another legal entity, at the time of their engagement with UNDP. It must be the individual who will decide if the contract should be IC or RLA, not UNDP

5. EVALUATION

Offerors will be evaluated based on the <u>Cumulative analysis</u>.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilised in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the candidates who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

5. 1. Technical qualification evaluation criteria:

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Technical Evaluation Criteria	Obtainable Score
Experience in developing information and education materials on sexual reproductive rights, HIV human rights and access to justice	30
Comprehensive understanding and knowledge of HIV and issues relating to stigma and discrimination in region	30
Verified practice on coordinating and producing peer reviewed publications for UN, development partners, government and	20
Experience working in multi-stakeholder process to develop education materials	20
Total Obtainable Score:	100

Only the offeror/candidate who have attained a minimum of 70% of total points will be considered as technical qualified offeror/candidate.

5. 2. Financial/Price Proposal Comparison:

- Only the financial/price proposal of offeror/candidate who have attained a minimum of 70% score in the technical evaluation will be considered and evaluated.
- The total number of points allocated for the price component is 100.
- The maximum number of points will be allotted to the lowest price proposal that is
 opened/evaluated and compared among those technical qualified candidates who have
 attained a minimum of 70% score in the technical evaluation. All other price proposals will
 receive points in inverse proportion to the lowest price. [Lowest Price x 100 / Other Price under
 Consideration] = Points for Other Candidate's Price Component.

5.3. Selection Method and Award Criteria:

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

• Responsive/compliant/acceptable, and

• Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula: Total Score = Technical Score x 0.7 + Finance Score x 0.3
