UNDP welcomes bids in USD. Full payment for the vehicles must be made to UNDP bank account in UAH based on official UN Operational Exchange Rate valid on the date of payment, prior to vehicles pick-up. Bank fees shall be

covered by the buyer. Pick-up of vehicles shall be arranged by the Buyer within one (1) week after full payment. No refund, no return is permitted.
