Terms Of reference

Background

Iraq is going through pivotal periods in its democratic and peace building trajectories. While the successful conduct and outcome of the April 2014 Council of Representatives (CoR) election appeared to have strengthened public confidence that the country could consolidate on its democratic processes and move towards development. While the election was widely acknowledged by national and international observers as a positive step in Iraq's democratic development, efforts at forming a coalition government by the leading political and religious blocs stalled for extended periods raising fears of a constitutional crises amidst rising wave of sectarian violence and insecurity in many parts of the country. These developments exerted considerable pressure of Iraq's fragile democratic institutions, including the Parliament and tasked their capacity to respond effectively to challenges of governance and constitutional democracy.

The Iraqi Council of Representatives (CoR) is the highest lawmaking organ of the country. In addition to its core legislative function of lawmaking, representation and oversight, the CoR is empowered by the Constitution to appoint and dismiss the president of the Republic, the Prime Minister and Ministers. It has the powers to aggregate citizens' opinion and inputs into draft legislations; initiates, amends and approves legislation and exercise oversight of executive branch agencies on issues of public interest and in the interest of transparency and accountability.

Iraq's 2005 constitution offers opportunities for citizens to have their voices heard in law and policy making processes including the national budget. The supreme law offers the Council of Representatives full authority to amend the national budget and evaluate the implementation of public policies.

Despite its enormous constitutional role as the immediate representatives of the people, the Iraqi parliament remains a young institution (the third parliamentary term started in July 2014). The parliament only began its fourth term in July 2014 since the introduction of the 2005 democratic constitution. This view perception could further be reinforced going by the high turn over of members resulting from the outcome of the April election.

UNDP Iraq has been supporting the Iraqi CoR through the "Strengthening Participatory and Accountable Governance" project. This includes, but it is not limited to:

- Strengthening the CoR's capacities for budget analysis through workshops to Members od Parliament and Staff;
- Developing the Representatives' Budget Office (RBO) documents through an inclusive approach; and
- Securing the ownership of the House of Representatives through the support of the House of Representatives and the agreement of the Speaker to contract a director of the RBO.

Scope of Work

With the agreement of the House of Representatives in Iraq for establishing the RBO, UNDP requires the services of a national director of this office to:

- Lead the practical establishment of the RBO through selecting researchers and staff who will work for the RBO;
- Manage the team on daily bases and organize trainings to his staff to make them able to achieve RBO's objectives;
- Organize budget analysis activities in the House of Representatives for MPs, staff and CSOs. This includes, but not limited to workshops, roundtables, conferences, public hearings;
- Produce factsheets, research papers and documents on timely budget issues;
- Produce publications including deep analyses on economic and social issues;
- Develop indicators for the evaluation of implementing the national budget through public policies; and

- Support the presidency offices, committees, members and the secretariat – as they require with information, research and analysis on fiscal, financial and economic topics.

Tasks:

Under the overall supervision of the Participatory Governance Sub-Cluster Coordinator and the designated technical advisor consultant will undertake the following tasks:

- Develop a training package on budget analysis to the RBO team and Parliament's staff;
- Develop a comparative study between the Iraqi national budgets for the last three budgets as the House of Representatives approved them;
- Establish and update a database on fiscal, financial, economic and social information related to draft budget laws and sector-related public policies. This database should be at the disposal of the members of the Parliament, committees and staff of the House;
- Develop comparative studies on parliaments and budget processes in countries that have like Iraq the full authority to amend the national draft budget;
- Develop key performance indicators (KPIs) to public policies sectors in light of experiences of other countries and present on them to all standing committees;
- Assessment of projects, programs and sectors to measure strengths, weaknesses, performance and progress;
- Synopsize and synthesize studies and reports prepared and published by national and international institutions on related sectors;
- Produce specialized studies and research to identify social and economic trends and anticipate future outlooks;
- Develop specialized research on feasibility and available resources and resources needed to be mobilized to achieved set objectives in the general policy of state;
- Produce reviews and policy briefs, factsheets and newsletters on timely financial, economic and social issues.

The RBO director leads teamwork and will be responsible for producing the below deliverables. These deliverables are changeable subject to UNDP's approval, in case unexpected incidents take place in the project, such as delay of the project or change of project scope, due to reasons uncontrollable by the Consultant.
