## **Award Criteria**

☑ Contract shall be awarded to the lowest Life-Cycle Cost offer of the technically qualified and responsive Bid.

Bidders must not subcontract parts of works, equipment or any other goods or services from another bidder participating in the tender. Bids submitted by two or more bidders shall be all rejected in case they are subcontractors to each other's bid, or a subcontractor to one bid also submits another Bid under its name as lead Bidder.

- **3.** The list of works required for the installation of solar collectors for domestic hot water for site 2 and site 3 are separated into distinct compartment of the BOQs, though the overall description and quantities remain unchanged.
- **4.** The BOQ for Site 1 is complemented with an additional compartment including the list of works required for the installation of solar collectors for domestic hot water.
- 5. The updated versions of the BOQs for Site 1, Site 2 and Site 3 are attached in Romanian and English.
- **6.** All other terms and conditions of the solicitation documents, except as amended herein, shall remain unchanged and shall continue in full force and effect.
