Questions:	Regarding the shipments for various locations I have found an incongruence between the Approximate packaging quantity in Annex A and the annual shipping and delivery cost in annex A-1. For example, regarding the shipping of the HDR (1 box weights approximately 25 LB) to various location, in annex A the total amount of boxes of HDR to be send to various location is 2170 that multiplied by 25 LB equals to 52624 LB which is higher compared to the sum of 200 LB per 90 countries (200LBx90=18000 LB) considered in Annex A-1. In this sense, what should I consider? Is the Annex A-1 used as a list of price?
Answer:	Please use the A-I sheet so that evaluation on equal basis can be done on all bidders.
