Here below are Answers to Questions raised regarding the above assignment:

1.

Questions:	Section 2, Item F: Award of Contract, paragraph 35. Right to vary requirement at the time of award by up to plus or minus 25% of the total offer without change in the unit price.
	Question: As print production is a custom manufacturing process, there are certain fixed costs based on publication specifications, coupled with a running cost per copy produced. As the quantity goes up, the unit price drops, as the ordered quantity goes down, the unit price increases. This clause does not work in print, if UNDP decides to increase your quantity, you will pay too high of a cost per unit. If UNDP decides to lower the total quantity, the print supplier will not have their costs covered. Can this clause be removed from this ITB?
Answer:	This is UNDP standard clause which could not be changed. The figure is UNDP best estimate and it is very unlikely the variation will be as high as 25%.

Questions:	Data Sheet, item number 35. I want to confirm that as publications are completed and then placed into the warehouse for distribution, we will be able to invoice UNDP for the print production. For example, once the English Report is complete, we can submit the invoice for that publication to UNDP for payment. Is that correct?
Answer:	Yes.

Questions:	Print Production Question: We see that the English Report is to print in June. The French, Spanish, Arabic and Portuguese Reports are to print in July. It is noted that the English Summary prints in June and the 5 additional language versions print in July. If we are able to produce multiple titles at the same time, this will yield a cost savings for UNDP. The following are various scenarios for group/gang printing that will help save costs: Question a) Can we base the pricing on producing the French, Spanish, Arabic and Portuguese Reports at the same time by gang printing since they are all scheduled to arrive in July? Question b) Can we base the pricing on producing the French, Spanish, Arabic, Portuguese and Russian Summaries at the same time by gang printing since they are all scheduled to arrive in July? Question c) Can we base the pricing on producing the English Report and English Summary together in June? Can we base the pricing on producing the French, Spanish, Arabic and Portuguese Reports at the same time as the French, Spanish, Arabic, Portuguese and Russian Summaries since they are to arrive in July?
Answer:	First, the schedule is tentative, so the timeline might change. Vendor would be informed in advance of changes in the schedule. Question a) Yes. Question b) Yes. Question c) Yes; if there are changes, the vendor would be notified in advance, and asked to provide a quote for any additional charges.

Questions:	Country Office Shipments: Will it be possible to provide us with the exact delivery address for each of the 90 Global Destinations? This will help us generate an accurate pricing proposal as well as detail the transit time from our location to each office.
Answer:	The address is provided in the attached list. Kindly be informed that all vendors MUST provide shipment and delivery price to this addresses.

Questions: Price Considerations. There are three components that make up the bulk of the pricing for this ITB. Labor Costs: These are the rates we set at are our facility for the production of the publications. This cost can be controlled by our organization and we can offer a three year commitment on those rates. Paper Costs: Paper costs are set by market conditions and the individual paper manufacturing companies. We cannot control the rates set by the market. We also cannot control if the Kallima and Rolland sheets will be continually manufactured over the duration of the contract. Shipping Costs: These rates are set by the freight companies and not controlled by our organization and current fuel rates and surcharges also play a role. Question/Suggestion: We understand the goal to enter into a 3 year LTA and welcome the opportunity. We would make the following suggestion and would like to know if **UNDP** agrees: Labor; we can and will be able to set rates for the three years as requested. Paper; we are willing to share with UNDP our paper cost invoices and will only adjust the paper rate based on demonstrated increases or decreases in the price charged to us by our paper suppliers. Will this be acceptable? Freight; We cannot lock in these rates since we do not have any control over what the freight companies will charge which takes into account fuel costs and their labor rates. We ask that shipping costs be updated each year with the ability for UNDP to handle the freight should they be able to obtain a lower shipping cost. Will this be acceptable? We need vendors to provide a comprehensive proposal to ensure we have an end-Answer: to-end price for the project. At this point time, vendors are expected to provide complete price proposal assuming papers as specified in the ITB will still be available until the end of the contract period. Should paper is not available in future, alternative and new pricing will be considered for this. Please provide the price based on best estimates for shipping cost. HDRO may elect to use DHL services should the shipping cost goes up during the project period as indicated in the TOR.
