United Nations Office for Project Services ("UNOPS") Afghanistan Operational Hub ("AFOH") invited sealed proposals from eligible and qualified offerors for the Supply, Delivery, Installation, Testing and Commissioning of Hybrid Solar/ Wind Power Plant in Herat Province, Afghanistan. Whereas UNOPS wishes to extend the deadline for proposal submission and as well as to revise Section IV: Schedule of Requirements Annex-A (Terms of Reference), of the RFP to include one (1) additional possible terrain details for installation of wind Farm.

Both inner envelopes shall indicate the Offeror's name and address and the RFP Case No.

The first inner envelope shall be marked "Technical Proposal" and shall contain one soft copy and two hard copies of all the duly filled and signed Returnable Bidding Forms and other documentation (except the Returnable Bidding Form F— Financial Proposal Form. The technical proposal shall be prepared in duplicate with one hard copy marked "Original" and the other marked "Copy". In the event of any discrepancy between the soft and/or the hard copies of the proposal, the proposal marked as "Original" shall govern.

The second inner envelope shall be marked "Financial Proposal" and include the duly completed and signed Returnable Bidding Form F— Financial Proposal Form and The financial proposal shall be prepared in one soft copy and two hard copies, with one hard copy marked "Original" and the other marked "Copy" In the event of any discrepancy between the soft and/or the hard copies of the proposal, the proposal marked as "Original" shall govern.

Distinct, separately sealed, both technical and financial proposals are requested from the offerors in order to evaluate them separately. Both distinctly sealed envelopes of technical and financial proposals shall be kept in another envelope (outer envelope), which shall be sealed as well. Non-compliance to this instruction shall result in rejection of the proposal received.

- 2. Section IV: Schedule of Requirements Annex A Requirement Definition/Terms of Reference, Clause no.5 (Location Details): an additional possible terrain (site C) for installation of wind Farm has been added which is inside the DABS compound next to the solar park. Further details are reflected in Section IV, Revision I.
- 3. Section IV: Schedule of Requirements Annex A Requirement Definition/Terms of Reference, sub-clause no.8.3.1 (Wind Farm, Location): a preliminary drawing of the site C has been added under clause 8.3.1. Further details are reflected in Section IV, Revision I.

All other terms and conditions of the Request for Proposal, except as amended herein, shall remain unchanged and shall continue in full force and effect.
