Questions and Answers

1 Q. Line No. 1: Stove – please provide photo.

A. Answer: kindly below a picture for the stove.

2	Q.	Line No. 15: Ladle – the size is 12 cm length or 12 liters capacity.
	Α.	Answer: Ladle stainless steel reinforced ladle 12cm length 0.25 cl Capacity.
3	Q.	Line No. 16: Skimmers – the size is 12cm length or 12 cm diameter.
	Α.	Answer: the size is 12 cm diameter.
4	Q.	Line No. 17: Cutting boards – what is the purpose and material (wood or plastic). The size indicated is cm or mm.
	A.	Answer: Cutting boards for vegetable and meat The size indicated is in 2 cm.
5	Q.	Item no. 8 : Stainless steel mixing spatula 91 Cm is not clear to us. Is it a spatula or a whisk. Could you please provide us with a picture or a reference model of the item?
	Α.	Please refer to the below pictures.



6	Q.	Item no. 14: Is the tray is made of stainless Steel, can we offer oven tray with size 60*45*5 cm or 60*40*2 cm, instead of 60*40*5 cm? If 60*40*5 cm is obligatory, then can we quote it made of aluminium? The material is not specified in your RFQ. the tray could be stainless Steel or Aluminum since it's not specified in the RFQ
	Α.	and according to the tray size it could 60*45*5 cm instead of 60*40*5 cm
7	Q.	Item no.13: May the capacity of Electrical Vegetable cutter be stated as minimum 350 kg/hour to enable bidders find more alternatives?
	Α.	For the capacity of Electrical Vegetable cutter yes it could be stated as minimum 350 kg/hour.
8	Q.	Item NO. 5: May the capacity of stainless steel double skin food carrying container be stated as minimum 30 Lt?
	A -	or the capacity of stainless steel double skin food carrying container yes it could be stated as minimum 30 Lt.
9	Q	Regarding s/s spatula with height 91 cm, since it will be used for mixing purpose, can we quote a whisk of 950 cm instead, as shown below;





Or if a spatula is a must, can we supply 100 cm long polyethilene spatula instead of stainess steel as below;

kindly note that all the material and equipment's needed for the kitchen should be stainless steel as requested in the RFQ we can't replace it by polyethylene. and the spatula item is totally different from the whisk proposed.
