### Pre Bid Meeting questions and responses

S / N	Question	Response
1	Where the Exalt ExtendAir Model/Part No: R5010 5 GHz, Devices will be use and How?	Kindly refer to Terms of Reference Term No. 6. One unit of Exalt ExtendAir point-to-point Microwave Bridge needs to be installed on the rooftop of a GDPDC office and the second unit needs to be installed on the AWCC radio tower (Hub) which is normally located at the Provincial Police HQ (PPHQ)
2	Is there any Diagram made Intranet Connectivity from MoI to GDPDC Centers where are based in 34 Provinces	Such a diagram does exist, but we may not be able to share it at this point. Furthermore, since MoI's intranet infrastructure is very big and complex, looking at the diagram will not give a clear picture of what the contractor is supposed to do. To make it easier to understand, intranet connectivity among all sites already exists and is managed and maintained by AWCC. The contractor is required to supply, install and test a set (2 units) of microwave bridges – one at the GDPDC rooftop and the other on the AWCC radio tower (regional hub). UNDP will coordinate these activities among the contractor, MoI – ICT and AWCC
3	Does it meant a new Wireless Access Points will be suggested by Client (UNDP) to install with Wireless NICs Card, the Quantities subject to Site Engineers suggestion where no possibility of wiring is and amount shall be applied to UNDP separately?	In some of the GDPDC offices where the structure is not concrete masonry, installing ducts may not be possible. In such a case, after thorough assessment jointly with UNDP and UNDP's approval, the contractor will be required to install wireless access points. The make and model is already specified in the BoQ.



4	Is the MoI having contract with AWCC already and provided/Installed to MoI regional Hubs in their one of Tower end in all 34 Provinces?	Yes. MoI's intranet infrastructure is managed and maintained by AWCC.
5	Is the Concept of using the Exalt ExtendAir Model/Part No: R5010 5 GHz between GDPDC offices to MoI Regional Hub within the Province which could be distance with in 24Km?	Please refer to Terms of Reference Term No. 6. The Distance between the GDPDC offices and regional hub will not be beyond 24KM. In cases where it is not possible to connect the GDPDC office to regional hub with one set, additional sets shall be supplied and connected in a daisy chain form to connect the two sites
6	If there is no LOS clear between GDPDC Office and Regional Hub, additional Microwave bridge shall be install, This is again Subject to Site Survey to provide accurate prices or Subject to Contractor technical team prior arriving in any GDPDC office for Installation, UNDP will provide additional charges if require in any province	Correct. Please refer to BoQ, the Contractor will be paid based on actual quantities of goods used. For example if a GDPDC office cannot be connected through one set of microwave bridges, additional set(s) will need to be supplied and the Contractor will be paid for the additional sets. The survey of whether additional sets are required shall be conducted and coordinated with UNDP and supplied only after UNDP's approval
7	Is the Contractor responsibility is only to Connect GDPDC offices to MoI regional Hubs where already MoI regional Hubs are operational to install PTP?	Yes, the Contractor is only responsible to connect GDPDC offices to regional hubs. From that point onwards, the connectivity is already in place and is beyond Contractor's responsibility. UNDP will coordinate with the Contractor, MoI – ICT and AWCC for IP address allocation, routing and connectivity matters
8	Please provide more clarity on (The Contractor shall be responsible for obtaining space allocation on the radio tower(s) and pay all applicable fees during and post implementation for a period of 12 months) space allocation for a period of 12 months.  Again subject to site survey	This is not subject to site survey. In all cases space is required on the radio tower (regional hub) for the microwave bridge. Whether the radio tower is AWCC's property or some other operator's property, they will charge for giving space. The Contractor is responsible to pay all applicable fees for a period of one year (12 months). In cases where a GDPDC office needs to be connected through additional sets in a daisy chain form going through additional radio towers, those fees shall also be covered by the Contractor for a period of one year (12 months).
