Design and Establishment of a Sexual Offenders Registry in Belize

TERMS OF REFERENCE

I. Background

Evidence based crime prevention strategies have, in recent years, gained much popularity in the Central American and Caribbean region with the establishment of observatories dedicated to the compilation and analysis of data regarding crime and violence. There has also been increased interest in fostering citizen participation and citizen reporting to develop public strategies and policies aimed to alleviate manifestations of crime and violence within their communities.

The Evidence based Information Management on Citizen Security in Central America (InfoSegura Project) is funded by USAID and UNDP and is specifically designed to improve the quality of information on citizen security that is being managed in Central America and the Dominican Republic and to provide reliable and high-quality data regularly to decision makers. This project was expanded to include Belize in 2015 and is geared specifically to support the establishment of the Belize Crime Observatory for the country.

The InfoSegura Project has been specifically designed to improve the quality of information on citizen security that is being managed in Central America and the Dominican Republic and to provide reliable and high-quality data regularly to decision makers. The project aims to achieve these goals:

- Improve the regional and national capacities for collection, monitoring, and processing of information on citizen security and their use in decision-making and policy formulation on both levels;
- Strengthen the capacities of the civil society to collect, analyse and process data on citizen security and monitor policies and Citizen Security programs; and
- Support knowledge management at the regional level to deepen knowledge and understanding of the root cause of violence and insecurity, and promote successful policies and practices of citizen security.

In Belize, as part of the efforts to substantially improve data quality and evidence-based policy formulation relating to sexual offences, the Ministry of National Security has requested, as a priority, the design and establishment of a Sexual Offenders Registry. The administration, update and maintenance of the Sexual Offenders Registry will fall under the mandate of the Crime Observatory, within the Ministry of National Security. The 2014 reforms to the Criminal Code, Chapter 101 of the Laws of Belize provide for the establishment of a Sex Offenders







Registry, to be the country's primary source of information on those persons who have been convicted of offenses of a sexual nature.

The Ministry of National Security (MNS), now wishes to procure the services of a **Project Consultant** to design and establish a **Sexual Offenders Registry** within the Crime Observatory of Belize.

II. Objective

To design and establish a Sexual Offenders Registry suited to the specific context and needs in Belize.

III. Activities

- Conduct an assessment of the existing information management systems within the MNS to determine whether the Sexual Offenders Registry could be housed within an existing system, or whether a new system is required.
- Develop a new system (i.e. database) if required.
- Design and implement the Belize Sexual Offenders Registry (BSOR).
- Formulate a User's Guide, Administrative Guide, as well as, a Standard Operations Manual, which includes protocols for security of the registry and guidelines for intergovernmental information sharing.
- Develop a maintenance and sustainability plan for the Registry, including an outline of human, technological and financial resources for its sustainability.
- Design training material (including on-line material) and deliver training workshops for CO and BSOR personnel.
- Provide recommendations for legislation changes, if needed, that would enhance the utility of the BSOR

IV. Outputs and deliverables

Planning: Detailed work plan

<u>Pre-assessment</u>: Assessment report comprising:

- review of best practices pertaining to Sexual Offenders Registries which would inform the design of the Sexual Offenders Registry in Belize,
- review of legislation in Belize related to the establishment of a Sexual Offenders Registry and Database; and
- Assessment of existing structures/databases to determine where the Belize Sexual Offenders Registry can be housed.

Design:

• Design specifications for the Sexual Offenders Registry including procedures, access levels and protocols, including recommendations for data sharing and legislative reform.







- Build a Sexual Offenders Registry that is compatibility with the technological infrastructure of the Belize Crime Observatory.
- Sustainability Plan for the BSOR, including job descriptions and competency requirements for technical staff for BSOR, technical requirements and budget.

<u>Installation:</u>

- Installation of the Registry database
- Administrative and User Guides for the Sexual Offenders Registry
- Delivery of a minimum of two training sessions on operation and maintenance of the Registry with appropriate staff within the relevant agencies

V. Scope of price proposal and schedule of payments

- Applications should propose a lump sum amount, which must be "all-inclusive." The
 contract price is fixed regardless of changes in the cost components. If travels are
 expected, this should be reflected in the cost proposal. Payments will be linked to
 deliverables.
- Duty travel can be Included in the contract's initial payment to include the actual cost of
 the contractor's travel to arrive at the designated Duty Station (based on actual ticket
 cost and Belize City DSA rate of USD\$250 and all other areas of the country at a rate of
 USD\$219 per day).

VI. Management arrangements

The Contractor will be directly supervised by UNDP Belize Programme Associate and the Deputy Coordinator of the National Security Council Secretariat. The Consultant will require approval/acceptance of output from the Belize Sexual Offender Registry Development Task Force before payment for a deliverable is issued. The Contractor is expected to liaise/interact/collaborate/meet with institutions that make up the Task Force. The InfoSegura







Project Liaison Officer will provide support to the consultant in reaching out to the actors of the Task Force for coordination of interviews and consolidation of documents

- In-depth knowledge of computer systems and technologies, applied knowledge of computer hardware and software systems, computer networks and network administration,
- Experience in the design and implementation of sexual offender registries, or similar criminal justice information systems is desirable
- Experience in drafting technical manuals

Combined Scoring method – where the qualifications and methodology will be weighted a max of 70%, and combined with the price offer which will be weighted a max of 30%;
