A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. $Sf = 1000 \times Fm / F$, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

Interview with the candidates may be held if deemed necessary.

1) GENERAL BACKGROUND

UNDP, the Ministry of Agriculture and Rural Development (MARD) in collaboration with the Ministry of Construction are working together to prepare for the full implementation of a five-year programme "Improving the resilience of vulnerable coastal communities to climate change related impacts in Viet Nam", which was approved by the Board of Green Climate Fund (GCF) by the end of Jun 2016.

Partners: MARD in close coordination with MOC and 07 Provinces of Nam Dinh, Thanh Hoa, Thua

Thien Hue, Quang Ngai, Quang Binh, Quang Nam and Ca Mau

Total fund: GCF - US\$ 29.5m (fully grant)

GoV – MOC: US\$ 8m (co-financed by Housing Programme)

GoV- MARD: US\$ 3.07m (co-financed by Mangrove and CBDRM Programme)

Timeframe: 2017-2021 (5 years)

The overall objective of the project is increasing the resilience of vulnerable coastal communities to climate change related impacts in Viet Nam through the three key set of outcomes as following:

<u>Outcome 1</u>: Storm and flood resilient design features added to 4,000 new houses on safe sites, benefiting 20,000 poor and highly disaster-exposed people in 100 communes

Outcome 2: Regeneration of 4,000 hectares of costal mangrove storm surge buffer zones

Outcome 3: Increased access to enhanced climate, damage and loss data for private and public sector application in all 28 coastal provinces of Viet Nam

The proposed GCF project seeks to scale up interventions that are already tested to increase the resilience of vulnerable coastal communities. Building on ongoing social protection programmes related to housing for the poor and marginalized, the project will incorporate storm and flood resilient design features in new houses benefiting 20,000 poor and highly disaster-exposed people. As part of an integrated response to managing flood and storm risks, 4,000 hectares of mangroves will be rehabilitated and/or planted to function not only as storm surge buffers, but also to provide ecosystem resources that can support coastal livelihoods. Moreover, to support and sustain both the impact of this project as well as future requisite government policy adjustments that strengthen the resilience of coastal and other communities, resources will be used to systematize climate and economic risk assessments for private and public sector application in all 28 coastal provinces of Viet Nam.

To prepare for the detail preparation of the project and to facilitate for the project approval processes regulated by both funding agencies and the Government of Vietnam, UNDP Vietnam is seeking qualified Vietnamese candidates to fill in the 03 positions as follow:

- 1. 02 Climate Resilient Housing Specialists (25 days for Resilient Housing Design and Management Expert 1; and 15 days for National Housing programme Expert 2)
- 2. 01 National Forestry Specialist (30 days)
- 3. 01 Disaster Risk Information Expert (25 days tbc)

The Consultants will work with the Sustainable Development Cluster (SDC) of UNDP, MARD, MOC and MPI to formulate inputs for relevant GCF Project components as part of the full Project Document for

2) OBJECTIVES OF THE ASSIGNMENT

This TOR is specifically for 02 national consultants on (i) Resilient Housing Design (Expert 1) and (ii) Resilient Housing programming in Viet Nam (Expert 2)

The Consultants will work together as a team to provide a full technical report relates to detail implementation plan for Housing Component (Component 1) of a harmonized GCF Project Document for UNDP and MARD – MOC for final appraisal and approval for implementation (tentatively from Q2, 2017). Specifically, the consultants will provide specific outputs as following:

- A full detail technical design in the housing component of GCF Project document that is verified with the local stakeholders in the provinces, line ministries and other development partners
- A implementation plan of the project with clear requirements and terms for each work packages
- A detail logic framework to monitor and report the progress of the component in line with the overall GCF Project Proposal logic framework

3) SCOPE OF WORK

Specifically, the tasks of the two consultants is summarized as following:

1. Literature review (joint)

- Support UNDP and MOC to review and analyse the 07 provincial reports on housing in Viet Nam and other related reports and documentation by MOC under Decision 48
- Suggest further data collection if needed to ensure the quality and comprehensiveness of the information. In case the data is missing, contact the province and suggest methodology and interventions to collect the information in a timely manner

2. Detail House Design & House Programming

Base on the initial literatures and project documentation, project feasibility studies and necessary stakeholder consultation:

- Conduct further desk review of available technical materials on good practices in storm and flood safe housing, the good practice measures that are technically feasible and affordable for consideration under the GCF top-up support (joint)
- Review technical specifications suggested to verify that top-up housing support provided will
 facilitate homes built to withstand a strong typhoon according to current disaster levels. Addressing
 environmental issues and recycle or utilising local materials should be considered in the design
 (joint)
- Consult by telephone and email with provincial and national level government technical experts on available options to provide top-up support to on-going government efforts in 2017-2020 (lead by Expert 2)
- Develop draft technical approach and costing for add-on GCF support per house for various sites (broadly in line with current budget estimates of 800-1500 USD in direct support as top up fund to government efforts) – lead by Expert 2
- Frame-out an overall approach, potential M&E system and work plan for the housing component of the GCF project- clearly articulating indicators, indicators, reporting process – Lead by Expert 1
- Recommend process for ensuring technical design application, implementation and monitoring during project implementation for discussion with Ministry of Construction and Provinces. – Lead by Expert 2
