DESCRIPTION OF REQUIREMENTS

BACKGROUND

The United Nations Human Settlements Program, UN-Habitat, is the United Nations agency for human settlements. It is mandated by the UN General Assembly to promote socially and environmentally sustainable communities, towns and cities with the goal of providing adequate shelter for all. UN-Habitat has been working in Afghanistan since 1992 on a wide range of urban and rural initiatives, from small-scale neighborhood level improvement schemes to community empowerment.

Under the leadership of the Ministry of Urban Development and Housing (MUDH), Independent Directorate of Local Governance (IDLG), Ministry of Interior (MoI) and Kabul Municipality, UN-Habitat is providing technical assistance for the Afghanistan Urban Peacebuilding Program (AUPP) in eight strategic cities: Kabul, Herat, Mazar-e-Sharif, Jalalabad, Kunduz, Farah, Nili, and Bamyan. The first phase of the three-year program (2015-18) aims to enhance delivery of safety services, improve local government responsiveness and accountability, and strengthen partnerships between communities and civil society. AUPP is funded by the Kingdom of the Netherlands and the Swiss Agency for Development and Cooperation (SDC).

AUPP's goal is: Women and men, girls and boys, in cities have increased trust in the local government's capacity to uphold rights, achieve safe, secure and inclusive cities, contributing to improved government legitimacy.

The program has three expected outcomes:

Outcome 1: Municipalities in collaboration with line departments better plan and implement demand-driven and inclusive services in the area of safety and security.

Outcome 2: Communities, particularly excluded and under-represented groups, increasingly and with a spirit of solidarity engage in civic affairs and municipal governance.

Outcome 3: National government establishes framework for accountable, transparent and participatory municipal governance in particular in the area of safety and security.

AUPP's main activities include:

Establishment of 95 Community Development Councils and 19 Gozar Assemblies.

Participatory city and community-level safety assessments.

Implementation of safety infrastructure projects.

Community-police-municipality consultations.

Strengthening Municipal Advisory Boards and their Safety and Security Sub-Committees.

National and city-level advocacy campaigns by civil society.

SCOPE OF WORK

In order to influence change in municipal policies and safety services, UN-Habitat Afghanistan is seeking Expressions of Interest (EOI) from eligible Civil Society Organizations (CSOs) for small grants to implement advocacy initiatives. The aim of AUPP's advocacy work is to complement its infrastructure projects with more systemic shifts in public attitudes and policies in order to make Afghan cities safer, particularly for vulnerable citizens. Through its advocacy activities, AUPP will support the capacity development of Afghan CSOs (networks, associations, entities) and, in parallel, strengthen an important channel for constructive citizen-state dialogue.

AUPP is seeking EOIs for advocacy projects that:

1. Address a behavioral and/or policy change on one or both of the following themes:

 Civic engagement: Advocacy projects under this theme should aim to increase and institutionalize dialogue between communities and local authorities (municipalities, line ministries, and police).

- Urban safety services: Projects under this theme can extend to a wide range of safety issues, including but not limited to personal security, environment, traffic and movement, use of public spaces.

2. Clearly demonstrate how vulnerable groups like women and girls, children, youth, the elderly, disabled people, people with substance abuse issues, IDPs and returnees will be positively impacted.

3. Include capacity development for the CSO as well as community members who will be engaged in the project.

4. Will be implemented in one or more of AUPP's eight target cities (Kabul, Mazar, Herat, Jalalabad, Nili, Bamyan, Kunduz and Farah).

ELIGIBILITY

- 1. This grant opportunity is open to national CSOs that:
- Are registered, non-profit, non-governmental civil society groups or networks.
- Have a track record of successful delivery of related activities.
- Have a verifiable organizational structure and resources in AUPP's target cities.
- Can demonstrate community participation and coordination with relevant government entities.
- 2. CSOs can apply for projects with a maximum budget of USD 25,000.
- 3. Advocacy projects can be developed at city, district or national levels.
- 4. Projects should be designed for completion by April 2018.
- 5. EOIs should not exceed three pages (template provided in Annex A) and must be submitted in English.

REVIEW STANDARDS

- 1. EOIs will be reviewed by a UN-Habitat Technical Evaluation Committee.
- 2. EOIs will be rated according to the quality of advocacy idea, in particular its relevance to:
- a) Afghanistan's urban environment
- b) AUPP program objectives
- c) Concerns of marginalized segments of society
- d) Community participation
- e) Originality and innovation
- f) Sustainability
- g) Organizational capacity

3. After EOIs are reviewed, selected CSOs will be invited to submit full proposals. Detailed guidelines on proposal preparation will be provided.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

CSOs interested in applying for the grant opportunity are invited to submit their EOIs by hand as indicated below, along with the required documents.

UN-Habitat subsequently intends to issue a Request for Proposal (RFP) to organizations who qualify (technically and financially) under the EOI review and are willing and able to execute advocacy projects as per requirements and standards.

REQUIRED DOCUMENTATION TO SUBMIT WITH EOI

Please note that this information will be used to select CSOs for subsequent RFP submission. Nonprovision of this information may therefore result in the CSO being excluded from further consideration.

a) Concept note (maximum three pages). Please use the attached template in Annex A.

b) Copies of the organization's valid registration licence from the Government of Afghanistan.

c) 1-2 contracts, completion reports or other documents demonstrating successful completion of similar projects.

d) CSO profile.

e) submission of EOI along with the requested documents on/before the deadline 30th November 2016 in sealed envolope.

IMPORTANT NOTICE

(1) The EOI must be clearly labeled "Expression of Interest - [Please indicate the EOI number as per cover sheet]" and must be received by UN-Habitat Kabul office no later than Wednesday, 30 November, 2016 at 2.00 pm via the above-mentioned contact information.

(2) This EOI does not constitude a solicitation. UN-Habitat reserves the right to change or cancel the requirements at any time during the EOI and/or solicitation process. UN-Habitat also reserves the right to reject submitted EOIs from further consideration if the CSO is not deemed to conform with the above conditions. Thus, submitting a reply to this EOI does not automatically guarantee that the CSO will be considered for receipt of the solicitation when issued.

(4) Only prospective CSOs that respond and are deemed qualified upon completion of an objective evaluation of their Concept Note will receive the final solicitation documents.

(5) UN-Habitat also reserves the right to send solicitation documents to CSOs who were identified through additional market research or others means to source the UN-Habitat requirements.
