there is no need to prolong it due to the bidding term extension.

1	If its not possible to indicate the remaining shelf-life?	For newly produces products please indicate «fresh batch».
2	At what stage it will be known the deviation in quantities of medicines to be supplied (+/- 25%)?	At the stage of contract concluding. The deviation is possible in case of existing budget deficit or surplus.
3	Is the delivery term deadline a stringent requirement from UNDP side?	Yes, we insist on meeting the deadlines. 100% of the total volume has to be delivered within maximum 4 months from the date of contract signing. Bids with long delivery term will be disqualified automatically.
4	If an applicant –resident of the Ukraine are not VAT free, will you evaluate price proposals excluding VAT?	No, according to procedures we evaluate the total proposal sum on each lot separately, including VAT (if applicable).
5	Can the company-resident that is no VAT exempted pass its goods to UNDP outside the customs territory of Ukraine?	UNDP accepts the goods only on terms DAP – Kyiv, MOH State Enterprise (SE) warehouse. UNDP doesn't consider a possibility of passing the goods outside the territory of Ukraine.
6	Can Ukrainian manufactures count on VAT exemption?	Ukrainian manufacturers are VAT exempted as the second party of the contract is UNDP.
7	Who will provide clearance from import in case if the supplier is non-resident? As VAT exemption could take much time, how to calculate delivery term correctly?	In case of the delivery from non-resident, MOH SE will handle customs clearance. Please, calculate the delivery term, considering that obtaining a VAT exemption certificate takes around 5 working days and customs clearance – about 2 working days.
