3.	In CACHE (Annex II), it might have been better if the hint was given as 'please fill up as appropriate' like Annex I	It is deemed as Annex I and NGO(s) can submit response as appropriate
4.	In case of consortium, whether the individual NGO or both the NGO will submit bid	Only mother NGO will submit bid
5.	Can any NGO apply for both RFI i.e. RFI-BD-2018-003 & RFI-BD-2018-004? If yes, then whether separate individual registration required or not.	If any NGO does have the similar mandates & vision like what is mentioned in the objectives of RFI 003 & RFI 004 then that NGO may apply for both RFI. One Ngo can apply for both RFIs with one registration
