Thank you for your interest to participate in the announced RFP. Below are the answers to your questions:

- a) **Yes**, a bidder, which is a group of legal entities, with one of the member legal entities registered outside Georgia is eligible to submit a proposal
- b) A lead entity, **either registered in Georgia or outside**, should meet the minimum criteria applicable to the lead company, specified in the Request for Proposal.

For example, in the Financial Standing Section of the RFP, the following criteria is indicated:

“Current Ratio for the last 3 years shall equal or be above 1

(In case of Joint Venture/Consortium/Association, **the lead company should meet the above minimum criteria**).”
