Many thanks for your interest in the UNDP RFP. Please see the responses to your questions below:

Q1: If consortium is formed for this bid, do the partnership agreement needs to be verified by notary?

A: Yes, as noted in the RFP, If the Bidder is a group of legal entities that will form or have formed a Joint Venture (JV), Consortium or Association for the Proposal, they shall confirm in their Proposal that they have designated one party to act as a lead entity, duly vested with authority to legally bind the members of the JV, Consortium or Association jointly and severally, **which shall be evidenced by a duly notarized Agreement** among the legal entities, and submitted with the Proposal (Section 2: Instructions to Bidders, item 14.1, page 8).

Q2: Does audited financial statements are required or it will be enough to submit statements signed and stamped by the company itself?

A: Bidders are allowed to provide either audited financial statements and/or income statements and balance sheets stamped and signed by the chief accountant of the company.

Q3: Does financial statements of both lead and consortium member companies needs to be presented?

A: Yes, it is advised to provide financial statements of both lead and member companies of the consortium.
