#25 Scope of work	While the methodology in the technical proposal should be extended to all 3 countries, two financial proposals are expected: 1) for Gambia alone and 2) for Liberia and Sierra Leone together	Does it mean there will be two different teams which will perform the studies separately and we need to furnish two separate teams? Please clarify  Answer: That is the choice of the bidder provided that the study result will be available six months later after signature of the contract.  If costs are combined for Liberia and Sierra Leone together, then should we have two teams working in parallel or the same team will do it in sequence? Pl clarify as this has a commercial implication.  Answer: It's up to the bidder to propose the best combination in his/her methodology ensuring the cost effectiveness.
