#	Questions	Clarifications
1	Item Number 6: Can you clarify the duster? Possibly share a picture of an example?	The item is a 'hand brush / du item 8 (sweeping tray). 
2	Item Number 45: Can the hand wash be in a 1 liter bottle?	Yes. If 1 liter bottles are supplied, we will only need half of the stated quantity (650).
3	Item Number 52: Purell is not available in 1000ml. Can 700ml or 1200ml be accepted?.	We use the 1200 ml purell
4	Item Number 52: Which type is it? Is it for a dispenser? (expect it to be a dispenser)	Yes, it is for a dispenser
5	Item Number 77: What Plum variant is it? Is it for a dispenser?	Handdesinfection gel plum 85 % ethanol. Yes for a dispenser
6	Item Number 96: What Plum variant is it? Is it for a dispenser?	The same kind as item number 77
7	Item Number 11a, b & c: Can you accept a 10 % deviation on these bags?	Yes, but the minimum size is 450 x 450 mm
8	Item Number 14 & 63: Are these items in rolls?	Yes
9	Item Number 84: Is this item a roll? The expected quantity per year says "66" - Is that a collie of 72 rolls - or only 66 rolls?	Please see the top of page 39 for the definition of the quantity for Item 84. 66 x 72 = 4,752 rolls
10	Item Number 31: May it have another size. Is it used for carrying round or is it placed on a sink?	They are to be at sinks. 300 ml are accepted
11	Item Number 33, 66, 76 & 87: May it be in a 300 ml bottle?	No. Item can be increased to 700 ml
12	Item Number 38: May it be in another size?	Yes, but no more than 2 kg
13	Item Number 41: Can you accept a 500 ml bottle?	No
14	Item Number 43: Can you accept a 1 ltr. bottle?	Yes
15	Item Number 70 & 90: Can you accept a 1 ltr. bottle?	Yes
16	Item Number 95: The expected quantity per year is 185. Is that in rolls or in collies?	It is 185 x 6 (quantity per item) = 1,110 rolls for the year
17	Do you prefer LEED certified chemistry or are you more focused on the total economy of the tender?	The tender will be evaluated on the basis of items supplied being technically compliant, as stipulated per the specifications, and lowest priced.
18	Are all the plastic bags in rolls or in pieces?	All plastic bags are in rolls except for Item 13 which is a box of 500 pieces.
19	Do you accept other certifications, than "Nordic Swan"?	Where stated 'Nordic Swan' is the minimum technical requirement. Other certifications will be accepted as long as they are equivalent or higher to 'Nordic Swan'

*** Please note: If deviations in volumes are used for items please remember to specify this clearly and multiply appropriately for annual usage.**

ie. Item no 70: We ask for 80 x 500 ml, if you deliver in 1 liter please calculate the annual price as 40 x 1 liter
