## **Answers to Inquiries from Prospective Offerors**

## **Question 1:** Where are the Annexes (Annex 1, 2, 3 and 4) located within the **Procurement Notice?**

<u>Answer 1:</u> The Annexes have not been uploaded separately within the Procurement Notice. Annex 1, 2, 3 and 4 are located within the RFQ Document at pages 9, 26, 27 and 53, respectively.

## **Question 2:** May a company which does not hold an ISO 27001 Certification submit a Quotation in response to the subject RFQ?

<u>Answer 2:</u> In the RFQ Document, ISO 27001 Certification has been listed as a document which must be submitted by the Offeror to establish qualification. Nevertheless, it is at the Prospective Offerors' sole discretion to submit a Quotation in response to the subject RFQ.

Question 3: May a company which does not hold an ISO 27001 Certification, but holds a GAB Certification submit a Quotation in response to the subject RFQ? The GAB Certification also contains the Information Security and Data Security outlined within the ISO 27001 Certification. In this regard, may the GAB Certification be also added to the RFQ?

<u>Answer 3:</u> In the RFQ Document, ISO 27001 Certification has been listed as a document which must be submitted by the Offeror to establish qualification. Given that the GAB Certification cannot serve in lieu of the ISO 27001 Certification, the GAB Certification cannot be added to the RFQ. Nevertheless, it is at the Prospective Offerors' sole discretion to submit a Quotation in response to the subject RFQ.

<u>Question 4:</u> Are there any other format for submission of a Price Proposal or will the Price Proposal be made within Annex 2 – Quotation Submission Form?

<u>Answer 4:</u> The Price Proposal must be made by filling out "Annex 2 – Quotation Submission Form" accordingly.
