In the State of the Nation Address (Sona), President Cyril Ramaphosa said government intend to create no fewer than two million new jobs for the youth in the next decade. The President reiterated this at the June 16th Youth Celebration held in Polokwane. The President further went on to indicate that his administration would support platforms that promote self-employment in rural areas and townships. He added that small business incubation centres would be rolled out to provide youth-driven start-ups with financial and technical advice.

Despite many efforts undertaken by both government and private sector focusing on entrepreneurship and participation of youth in the labour market, youth unemployment still needs attention and various interventions lack impact.
