Brief Description of the Required Services <sup>1</sup>	Indonesia is recognized as a country with extraordinary species richness that attracts attention and admiration of people around the world. BAPPENAS (2003) recorded not less than 704 mammal species (ranked as the most in the world; Maryanto et al. 2007), 1598 species of birds (ranked 4 <sup>th</sup> most; Sukmantoro et al. 2007), 270 species of amphibians (ranked 5 <sup>th</sup> most), 600 reptile species (3 <sup>rd</sup> most) and 1600 butterfly species (most) inhabiting land habitats and waters in this vast archipelago (Appendix of Ministry of Forestry Regulation No. P.57/Menhut-II /2008). Among ASEAN countries, Indonesia has the National Biodiversity Index which reaches a value of 1, bring Indonesia as the highest biodiversity country in Southeast Asia (von Rintelen, Arida, & Häuser, 2017).
	In the past three decades, more and more Indonesian animals have been included in the IUCN's 'endangered' list. In addition, many Indonesian animals are included in the CITES Appendix list. Noerdjito and Maryanto (2001) as editors of the book "Protected Types of Indonesian Legislation" include a long list of Indonesian fauna protected by law based on various laws and regulations since the Dutch era (Dierrenbeschermings Ordonantie in 1931) up to Government Regulation No. 7 of 1999. The list included 130 species of mammals, 390 species of birds, 48 species of reptiles, 8 species of fish, 19 species of insects, 12 species of mollusks, 9 types of crustaceans and other animals. In 2018, through the Regulation of Ministry of Environment and Forestry No. P.20 / MENLHK / SETJEN / KUM.1 / 6/2018 the list has been added protected species animals which currently amounted to 794 species.
	Those protected wild animals are believed to have very high economic value, especially endemic animals that only live in Indonesia or even only on an island in Indonesia. Even though wild animals are protected, the facts show that hunting and illegal trade continue to occur and tend to increase. This can be seen from the high number of wildlife crimes. In 2015-2018 it is recorded that more than 609 arrests of perpetrators of illegal hunting and distribution (Ditjen Gakkum LHK, 2019). Tigers, elephants, rhinos, primates, birds, fish, and reptiles of various types become commercial commodities for perpetrators. Financial Transaction Analysis and Reporting Centre (PPATK) estimates that the value of animal trade reaches more than 13 trillion rupiah per year (KLHK, 2018).
	The problem that arises later is the difficulty of the prosecution to determine the amount of compensation that must be prosecuted for illegal trading. In addition, with the current valuation method where economic reviews are highlighted, valuation results tend to be undervalued/overvalued and or debatable/multiple interpretations. This is because wild animals have many values such as: biological values, ecological values, economic values, and social values. In this regard, there is a need of study of determining the economic value of protected wildlife for the purposes of legal proceedings. Through the study, it is expected that the most appropriate methodology and economic values of rational wild animals will

Noerdjito and Maryanto (2001) as editors of the book "Protected Types of Indonesian Legislation" include a long list of Indonesian fauna protected by law based on various laws and regulations since the Dutch era (Dierrenbeschermings Ordonantie in 1931) up to Government Regulation No. 7 of 1999. The list included 130 species of mammals, 390 species of birds, 48 species of reptiles, 8 species of fish, 19 species of insects, 12 species of mollusks, 9 types of crustaceans and other animals. In 2018, through the Regulation of Ministry of Environment and Forestry No. P.20 / MENLHK / SETJEN / KUM.1 / 6/2018 the list has been added protected species animals which currently amounted to 794 species.

Those protected wild animals are believed to have very high economic value, especially endemic animals that only live in Indonesia or even only on an island in Indonesia. Even though wild animals are protected, the facts show that hunting and illegal trade continue to occur and tend to increase. This can be seen from the high number of wildlife crimes. In 2015-2018 it is recorded that more than 609 arrests of perpetrators of illegal hunting and distribution (Ditjen Gakkum LHK, 2019). Tigers, elephants, rhinos, primates, birds, fish, and reptiles of various types become commercial commodities for perpetrators. Financial Transaction Analysis and Reporting Centre (PPATK) estimates that the value of animal trade reaches more than 13 trillion rupiah per year (KLHK, 2018).

The problem that arises later is the difficulty of the prosecution to determine the amount of compensation that must be prosecuted for illegal trading. In addition, with the current valuation method where economic reviews are highlighted, valuation results tend to be undervalued/overvalued and or debatable/multiple interpretations. This is because wild animals have many values such as: biological values, ecological values, economic values, and social values. In this regard, there is a need of study of determining the economic value of protected wildlife for the purposes of legal proceedings. Through the study, it is expected that the most appropriate methodology and economic values of rational wild animals will be obtained which have considered biological values, ecological values, economic values, and social values.

#### C. Context of this TOR

The results of economic value assessment will be very useful for investigators (Indonesian National Police and Ministry of Environment and Forestry), prosecutors, and the panel of judges who process court cases related to wild animal crimes in the process of preparing case files, prosecutions, and up to the judge's decision. In addition, it is also important for civil society to raise awareness about the preservation of the intended wildlife.
