	Q	Scope of work 1, point 1.1 and 1.2, could you explain whether the meeting is on national or provincial level?
4	A	The meeting is on national-level. Selected bidder is expected to be responsible only for substantial matters. Logistical requirement would be organized by UNDP.
	Q	Are we expected to update the MACC regularly?
5	A	The data for MACC should be updated regularly. All the database and calculation used for the development of MACC must be handed over to UNDP and Directorate General New and Renewable Energy and Energy Conservation
6	Q	Based on the ToR, the meeting will not only be conducted at the national- level, but at provincial level too. Is it correct?
0	Α	Depends on the scope of work, as we will conduct both at national and also provincial level, particularly at four locations of our pilot projects.
7	Q	Do we need to discuss about renewable energy only, or we need to discuss energy in general?
	А	No, we only focus the new renewable energy powerplant
8	Q	Bio fuel is a renewable energy, but is it fine to include bio fuel mixed with fossil fuel in our assessment?

9	Q	Is it correct that we only need to create MACC for the 4 provinces and only an overview for national level?

	A	The exact completion date and any contract extension plan will be discussed once the project is starting.

	Q	For the site visit, is it enough for only 3 days? Can we extend it?
12	A	We take three days based on our assessment. Adding more days is allowed as part of proposed methodology, however, please note that it will financially impact the proposal as well.
	Q	Where can we assess related data from?
13	A	Directorate General of New and Renewable Energy & Energy Conservation as the implementing partner of MTRE3 project will facilitate required data.
14	Q	Should we coordinate with the sub-national of governmental agency?

15	Q	Why UNDP selects only one of the renewable powerplants? What is the objective and what do you expect? Do you think the best approach will be
15	A	bottom-up or top-down? Internal assessment of UNDP shows that field visit to one renewable energy powerplant in each pilot province will be sufficient to develop MACC.
16	Q	Shall we include the administration fee? Could we add more administration officer in the team?

	A	As it is stated in the Tender Document, the table is only example, you could add more people based on your methodology and approach with justification.
17	Q	Are there any possibilities of extension of the project timeline?
	А	Yes, there always be possibilities but it will be discussed later after we have selected bidder.
18	Q	Is it possible to make a consortium?
	Α	Yes, it is. But please note that you need to attach required documentation for both companies.
