ATTACHMENT 1- ANSWERS TO QUESTIONS FROM PROSPECTIVE BIDDERS

Question 1: With reference to the evaluation criterion “*Minimum two contracts of similar value for supply of municipal waste vehicles, machinery or equipment implemented over the last three years.*”, should each member of JV/consortium meet this minimum evaluation criterion? Please kindly clarify whether we are qualified for bidding in the following case; Our manufacturer partner has completed two similar contracts. Our firm had an Agent/Dealer agreement with that manufacturer and did not have any related experience.

Answer 1: As per the ITB, this criterion shall be met cumulatively by JV/Consortium members. In case that only one of the JV/Consortium members had completed two contracts and the other members does not have any similar experience, the bidder as JV/Consortium would meet the evaluation criterion.

As an agent/dealer without any JV/Consortium agreement with the manufacturer, your firm would not qualify for bidding since your firm does not have any related experience. Agent/dealer agreement would not make the manufacturer be considered as a bidder without a JV/Consortium agreement between your firms.

As per the ITB and regarding your case, your firm and the mentioned manufacturer shall have a **duly notarized JV/Consortium agreement** to meet the evaluation criterion as a qualified bidder.

Please kindly note that the following forms shall be submitted accordingly, in case of bidding as a JV/consortium;

- Form C shall be completed and submitted with a notarized JV/Consortium/Association agreement within the bid.
- Form B shall be submitted separately for each member with company documents for each member.
