## SECTION 5A: STATEMENT OF WORKS

### Rehabilitation of Pumping Stations No.08 , 03 and 02 in Khan Younis

#### Project Description:

The scope of works includes all civil, mechanical and electrical works required for the rehabilitation and upgrading of three existing pumping stations in Khan Younis as stated in the tender documents. The tender includes the following main works:

- 1) Pumping station works PS8.
- 2) Service Building and yard Works PS8.
- 3) stormwater Works PS8.
- 4) Electrical Works PS8.
- 5) Mechanical and elec. works for Al-Wafiya and Hesbit Al samak PS.
- 6) PLC control system for the infiltration basins in Al Fukhary area.

#### Additional Precautions:

##### Project Location and Safety and Security Requirements

The site location for pumping station PS 08 and infiltration basins is located in the south-eastern part of Khan Younis Governorate in Al Fukhari area close to European Hospital. Pumping stations PS 02 and PS 03 are located in Khan younis city.

Therefore, extra precautions and measures are required by the contractor to ensure the safety and security of all individuals inside and around these sites, taking in consideration that the sites are under operation.

It is also emphasized that construction works shall not by any means interfere with, disturb, or interrupt the daily activities of the ongoing and operational projects of KY WWTP including the treatment plant, the effluent pressure line, the main electrical power supply line, the infiltration basins and the existing pumping system of Khan Younis City or endanger the safety of the residents, employees and visitors.

The contractor shall visit the project sites to become familiar with the conditions and nature of the working area, the structures, the vicinity, and the free space available for maneuvering, performing the work and for storing the construction materials. In general, the contractor shall become familiar with all the conditions and circumstances which may affect the way he will perform his work.

The contractor shall take all necessary measures and make all necessary arrangements to assure the continuity of pumping the raw sewage from pumping stations 8, 3 and 2 to KY WWTP without stoppage or interruption. The contractor shall take all necessary measures to prevent any interruption of the existing infrastructures and utilities. In case of disconnecting any services, the contractor shall provide written notification and shall seek prior approval from the concerned authorities and the Engineer.

The prices quoted by the contractors in the bill of quantities, following their visit to the site, shall be considered to include all what is required to carry out the work under the local conditions, including the foreseeable and unforeseeable expenses that will be required to complete the work according to the contract and to the satisfaction of the Engineer.

### **Local Context**

The Contractor represents that it is aware of and has considered in its bid price, the security and local circumstances of the Gaza Strip, including without limitation closures of border crossings between the Gaza Strip and Israel, delays in custom procedures, delays in access for people, supplies and construction materials and equipment into the Gaza Strip, which could affect the progress of Works.

The Contractor further represents that it has familiarized itself with these circumstances through the construction and maintenance stages of the Works and has taken into account all the consequences that may arise due to these circumstances.

The Contractor further represents that it is aware of the political, diplomatic and legal context prevailing in the Gaza Strip and shall abstain from contacts of a political nature. Should issues relating to the specific political, legal and diplomatic context arise in the implementation of this Contract, the Contractor shall immediately inform UNDP. The Contractor shall not disclose such issues to third parties.
