TOR	How many team compositions will carry the assignment?	According to the TOR, UNDP Require the following expert  a) Team Leader b) Senior Audit Expert c) Junior Experts d) Junior Expert audit The project will have the following monitoring mechanism 1. The agriculture experts will only look to the technical areas/ or quality 2. The audit team will verify the reports/ data/ and expenditures  Note: The team leader and senior expert will not go to field, only the two junior experts will visit the fields.	
TOR and Bid datasheet	If we increase the number of staff in the financial proposal will this effect on our rating?	All bidders are allowed to increase the number of proposed staff in their technical proposal with justification and it should be reflected in the financial proposal accordingly. The evaluation method for technical and financial proposals will remain unchanged as explained in Article 30 of Instruction to Bidders of RFP. The evaluation method which will be used if "Combined Scoring Method, using the 70%-30% distribution for technical and financial proposals respectively".	

TOR	How the junior staff will be managed and monitored since the team leader and senior expert will not have any visits to fields?	The team leader will monitor and do the cross check of the report. And the Team leader with senior expert, will verify the reports provided by junior staff. Moreover, the monitoring team needs to provide geo-tagged photos, signed questionnaires and other verifiable sources of information. The team leader can quality check the data based on these evidences.
TOR	Who are the implementing partners? Will it be increased in the future?	There are two implementing partners:  1. Ministry of Agriculture: The direct partner will be the Program Management office (PMO) for MAIL there will be 3 exercise in a year and 9 exercise through entire duration of contract.  2. Roots of Peace: There will be only one exercise per year for the 3 year there will be three exercise.  For now, these are the implementing partners. If any further implementing partners are included, they will be put in one of the above categories.
TOR	Can a spot check contractor of UNDP apply for this process?	UNDP Contractors who are having NIM Audit contracts are not eligible to apply for this process
TOR	What is the reporting period mechanism?	For Ministry of Agriculture for the following period the report is required.  One report from January to May  2 <sup>nd</sup> Report from June to August  3 <sup>rd</sup> Report from September to December  For Roots of Peace for the following period the report is required  One report from Jan to December. TOR	How many projects use this LTA?	This LTA is covering the requirements of MAIL and Roots of Peace only. Incase of need and inclusion of additional IPs, UNDP will notify LTA holders and will amend the LTA accordingly.
TOR	In the RFP the number staff and days are fixed or variable?	The number of proposed days and key staff are fixed, if the firm needs to increase/decrease the number of days/staff, they need provide detail justification.
TOR	As stated in the TOR how the experts select 25% in field office, please explain?	In each exercise, the monitoring team needs to visit 25% of communities in each district. They need to visit all districts in each reporting cycle. This can be further discussed during the inception phase.
TOR	Do you have any LTA now for the same activity?	Not for similar projects.
TOR	The report will be output based or outcome based?	The reports are output based and physical verification.
TOR	In the TOR the key staff are required to have agriculture background. Does UNDP accepts staff from other background, e.g. engineering etc	The proposed staff will be evaluated based on criteria set in Staff Qualification and experience requirement stated in TOR.
TOR	It is indicated in TOR that, the team leader must possess the knowledge of local languages. Does this effect our scoring during the technical evaluation if we add the international staff?	The evaluation scoring sheet specifies score for language competencies. The higher marks will be given to candidates who can demonstrate knowledge of all three languages (English, Dari and Pashto).
TOR	What is the type of contract UNDP will award and how the inflation will be addressed?	This is a long-term agreement. The costs are fixed.

TOR	The company is currently in contract negotiations to provide independent, third-party monitoring services for INL for the CBARD programs, as a subcontractor for FIAT. If this contract is signed, would that pose any issues in bidding for UNDP's FMSC LTA?	Please note that in the project we have various levels of monitoring. This LTA is for UNDP monitoring level while INL as donor of CBARD has contracted you for a different level of monitoring. UNDP believes that it isn't appropriate to have the same company doing two different levels of monitoring. Unless if it can be adequately demonstrated, that there is no conflict of interest.		
Data sheet	The criteria for key staff in Data sheet doesn't match with TOR. Could you please explain which one shall prevails?	The criteria explained in the TOR is correct. The datasheet and evaluation criteria is now updated.		
Data sheet	There is a discrepancy between the CV requirements listed on page 22 and those listed on pages 25 and 35. Could you please verify which set of guidelines we are to follow?	The criteria explained in the TOR is correct. The datasheet and evaluation criteria is now updated.		
Data sheet	The grading criteria suggest that we are only required to submit 4 CVs. However, it is expected that junior staff will be recruited from the provinces in which they will be working (Badghis, Farah, Jawzjan, and Nangarhar). Can you please confirm whether you only want one sample CV for each of the junior positions, rather than one for each province?			
Data sheet	Are the number of days for each position per round of spot checks fixed? If so, could you please verify whether the values in Table a)	The total number of days column is accurate. The days in the remarks were typo. Please note that CBARD-W and CDRRP have two provinces		

	are correct? Currently they say 6 days per province for CBARD-W for the senior position (which should amount to 12 days), but only allot 6 days. The issue is the same for CDRRP, with 3 days per province, but only 3 days allotted (rather than 6). On the other hand, the junior roles say 6 days per province for CBARD-E, but allot 10 days.	each so when we say CBARD-W 5 per province, means 10 for CBARD-W in total.  In any case, the revised financial template has adjusted the remarks column.	
Data sheet	In the attached data collection forms, the efficiency category asks "Are the activities 'best value for money?' Given that this is a monitoring exercise, not a comprehensive evaluation, could you please provide additional guidance on how 'best value for money' is to be calculated?	This question doesn't ask for any evaluation type of assessment. This is more observational based on field visits. For example, if you are reviewing a greenhouse in Farah, you may ask people how much does it cost around that area to do the same? Similarly, when you look at breakdown of the costs, you may find items that are really expensive. Or you may see if people are using the items for stated purpose or not.

If your company is currently contracted to monitor CBARD Programme activities for next 3 years by donors or government, then the stated company may not be eligible to bid for this tender.

At a minimum of 5 years' relevant auditing experience  While later in this Section, under Technical Evaluation Criteria, it states that evaluation will be based on the following criteria for these two positions:	The criteria explained in the TOR is correct.
