### 3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS:

### I. Academic Qualifications:

Advanced university degree (master's degree) in Law, International Law, public administration or another relevant field.

## II. Years of experience:

- At least 7 years of relevant working experience in the formulation of laws, legislation and policies related to social development and disability development.
- Experience for the legal analysis and formulation of social inclusion frameworks and legislations in developing countries including Cambodia
- Strong knowledge of national and international frameworks and policies in relation to disability inclusion and human rights.
- Previous experience in research and study related to UNCRPD and other legal frameworks related to disability.

## III. Competencies:

- Demonstrated ability to communicate effectively with government and development partners.
- Good facilitation and presentation skill.
- Strong interpersonal skills, ability to work with people from different backgrounds to deliver quality products within short timeframe.
- Be flexible and responsive to changes and demands.
- Be client oriented and open to feedback.
- Displays cultural, gender, religion, race, nationality and age sensitivity and adaptability.
- Treats all people fairly without favoritism.

### 4. FINANCIAL PROPOSAL

This is a <u>Lump sum output-based contract</u>. Therefore, the interested offerors are requested to submit <u>Final All-Inclusive Price</u> with cost breakdown.

#### 5. EVALUATION

Offerors will be evaluated based on the Cumulative analysis.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the Offerors who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

## 5. 1. Technical qualification evaluation criteria:

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Only the offerors who have attained a minimum of 70% of total points will be considered as technical qualified offerors.

# 5. 2. Financial/Price Proposal Comparison:

• Only the financial/price proposal of offerors who have attained a minimum of 70% score in the technical qualification evaluation will be considered and evaluated. The total number of points allocated for the price component is 100. Below is the formula used for this evaluation:

Rating for Financial Proposal = (Lowest Priced Offer / Price of the Offer Being Reviewed) x 100

#### 5.3. Selection Method and Award Criteria:

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

Responsive/compliant/acceptable, and

 Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula: Total Score = Technical Qualification Score x 70% + Financial Score x 30%
