## **ATTACHMENT-1: “ANSWERS TO QUESTIONS” FROM PROSPECTIVE PROPOSERS**

**Question 1: Does the subject ITB has any relation with the ITB issued on 08 January 2020 for “Procurement of CNC Lathe Machine and CNC Vertical Milling Machine for Izmir SME Capability and Digital Transformation Center” with Ref. No. UNDP-TUR-ITB(MC1)-2020/01?**

*Answer 1: The ITB issued on 08 January 2020 for “Procurement of CNC Lathe Machine and CNC Vertical Milling Machine For Izmir SME Capability and Digital Transformation Center” with Ref. No. UNDP-TUR-ITB(MC1)-2020/01 has been cancelled on 03 February 2020 due to absence of an eligible, substantially responsive and technically qualified bid.*

*The subject ITB issued on 12 February 2020 with Ref. No. UNDP-TUR-ITB(MC1)-2020/05 is the second round of the cancelled ITB for the same CNC Lathe Machine and CNC Vertical Milling Machines for Izmir SME Capability and Digital Transformation Center. In the last issued ITB document, there are a few **revisions in qualification criteria, minimum bid security amount and technical specifications (digitalization requirements)** compared to those of the cancelled ITB. The bidders are requested to consider these revisions while they prepare their bids.*

**Question 2: Are the bidders who submitted a bid security for the cancelled ITB required to submit a new bid security for the subject ITB?**

*Answer 2: For the renewed ITB with Ref No. UNDP-TUR-ITB(MC1)-2020/05; a new bid security **which conforms to the requirements of the new ITB** (such as **minimum amount and validity period**) shall be submitted by bidders.*

*Please make sure that, as per Item 7 “Bid Security” of Section 3 “Bid Data Sheet” of the subject ITB document, **original bid security is delivered to the address mentioned in the ITB document (with a PDF copy submitted as part of the electronic submission) on or before the submission deadline** indicated in e-tendering system.*

**Question 3: What will be the product that will be produced by these machines and what kind of raw materials will be processed by these machines to produce that product?**

*Answer 3: The product that will be produced using these machines at Izmir SME Capability and Digital Transformation Center is **pneumatic cylinder**. The raw material that will be processed in CNC Lathe Machine is **steel** and the raw material that will be processed in CNC Vertical Milling Machines is **aluminum**.*
