CONTEXT/BACKGROUND

The project on “Strengthening Arab Economic Integration for Sustainable Development (AEISD)”, implemented by UNDP, sets among other objectives, the provision of technical assistance to the League of Arab States (LAS), specifically the Economic Sector and relevant organs, and member states of the Pan Arab Free Trade Area (PAFTA) in working towards a deepened integration, including preparations for the Arab Customs Union. The second AEISD important component relates to strengthening the Arab economies connectivity in the region with the expectation that these efforts would be translated into more contribution of economic integration to better livelihood of people, more employment opportunity and improved participation and involvement of the private sector.

Trade in services has gained importance in the majority of Arab countries – a consistent pattern for developing countries that embark on the economic diversification. According to statistics by the Arab Monetary Fund (2017) on trade by Arab economies, contribution of extractive industries (i.e. mining, oils and gas) to GDP continue to be on the downward trend, while manufacturing, agriculture and services are rising.

Trade in services has a significant potential to fight poverty in Arab countries as it has been empirically proven by recent UNCTAD research¹ work that the services sector share in employment and GDP has been on the rise for most Arab countries during the last decade. The services economy has also an

undeniable role in the promotion of inclusiveness and particularly on the economic empowerment of women as well as promoting the SDGs in the context of the regional economic integration.

For the Moroccan economy, the pattern of importance of services to the GDP is consistent during the period from 2012 to 2017 in which, trade in services accounts for around 27 percent of the GDP in 2017 (against the average ratio of 21 percent of GDP of all Arab economies) with average growth rate of 4 percent on annual basis.

Given the inter-sectoral linkages and critical roles played by carefully designed national regulatory and incentive-based policies, many developing countries require technical assistance to identify and construct effective institutional frameworks and policy reform packages needed to ensure development gains from services and services trade liberalization.

To this effect, UNCTAD's technical assistance in the area of Services Policy Reviews (SPRs)² is designed to guide requesting countries through a systematic review of the economic, regulatory, institutional and trade policy environments characterizing their services sectors with the aim to assist these to improve regulatory and institutional frameworks and to identify trade policy options that advance national sectoral development objectives. The ultimate SPR goal is to strengthen the capacity of developing country policy makers, regulators and trade negotiators to capture new market opportunities and address national challenges in key and sometimes sensitive services sectors.

To assist Morocco's efforts towards Arab economic integration, particularly in the area of trade in services, UNCTAD and UNDP are undertaking at the request of the Moroccan authorities a services policy review (SPR), which will cover the following three (03) services sectors selected by the Ministry of Industry, Trade, Green and Digital Economy (MITGDE):

- (i) Logistics Services in the transportation and distribution of pharmaceutical products,
- (ii) Distribution services, comprised of wholesale services trade and retailing, and
- (iii) Professional Services Sector: limited to the sub-sector on Legal Services.

The SPR analysis would cover the broad economic and associated social dynamics of the national services sector as a whole and examine the potential of new markets as well in particular in Arab and African countries.

Consultancy work, to be undertaken by the national expert, under the supervision of and with guidance from UNCTAD in collaboration with UNDP, would contribute to the comprehensive review report on the three identified sectors. The expert will be part of the national working team, including the MITGDE concerned officials in conjunction with UNCTAD and UNDP team. It is expected that his work be integrated within the consolidated SPR final report.

The execution of this consultancy work is carried out under UNDP rules and regulations applicable for Delegated Direct Implementation and fully aligned to UNDP Programme and Operations Policies and Procedures (POPP). Specifically, the expert discharges his/her their duties under the supervision and guidance of the Chief Technical Advisor of UNDP and UNCTAD Experts with regard to the SPR substantive activities under this assignment.

SCOPE OF WORK

The Service Policy Review (SPR) would guide the government to design and implement a strategic action plan for Logistic services in the transport and distribution of pharmaceutical products in Morocco, and to identify trade policy options to advance national sectoral development objectives, as well as to enhance the competitiveness of the sector in foreign markets at the regional level as a priority, as well as integration in the global services market. The expert will be responsible for the quantitative and qualitative analysis of the current status of Logistic services supplied in the transport and distribution of pharmaceutical products.

The methodology of the trade policy review is based on the Service Policy Review (SPR) methodology, designed by UNCTAD, with due account for corresponding adjustments to conditions and operational environment of Morocco. Accordingly, the final report of the review of this sector should cover, inter alia, the following:

- Economic review of the Logistic services supplied in the transport and distribution of pharmaceutical products;
- Role and performance of the sector;
- Regulation, institution, and policy measures impacting the said sector;
- Trade liberalization commitments affecting this sector at bilateral, regional and multilateral level;
- Analysis of Strength-Weakness-Opportunities-Threats (SWOT) of the sector.

Expectedly, from the findings of the review, Morocco will identify the corresponding institutional and policy measures to further develop the supply side capacity in the Logistic services in the transport and distribution of pharmaceutical products, design adequate sequencing of reforms, elaborate a coherent and comprehensive strategic framework for the Logistic services supplied in the transport and distribution of pharmaceutical products, and identify trade policy options that advance national sectoral development objectives and improve the services exports to potential foreign markets.

The focus of the assignment is to review and analyze policies of Logistic services in the transport and distribution of pharmaceutical products from a trade in services perspective. As per the SPR aim, the Moroccan government will be equipped with the following:

- A set of reform (or reform measures) to enhance performance and competitiveness of the Logistic services in the transport and distribution of pharmaceutical products
- A set of development objectives that reforms are expected to be achieved with concrete timelines;
- A set of indicators against which the effects of proposed reforms could be assessed; and
- An action plan designating national entity responsible to lead implementation of every recommendation, as well as an approximate timeframe and sequence for the implementation of each recommendation.

For the purpose of this assignment, the expert will focus on the collection of trade statistics, quantitative and qualitative analysis of the Moroccan Logistic services in the transport and distribution of pharmaceutical products. The review should prioritize the analysis of factors, productive and supply capacity of this sector in the pursuit of more efficient performance. At the same time, outputs of the policy review would contribute to long-term objective of enhancing Moroccan Logistic services providers in the transport and distribution of pharmaceutical products to access foreign markets.

Main activities

The expert will perform the following duties:

1. Review the economic, regulatory, institutional and trade policy environments that characterize the Logistic services in the transport and distribution of pharmaceutical products in Morocco, as well as available literature, references on services-related dimensions for these Logistic services. This would be carried out in accordance with the requirements of a comprehensive SPR report, including the role of this sector within the national economy and its contribution to it;
2. Analyze the impact of this sector in Morocco's economy and trade policy;
3. Provide detailed analysis of the current account, economic conditions for Logistics services in the transport and distribution of pharmaceutical products composition (flows and trends of transport and distribution services of pharmaceuticals output, employment, investment, value chains, and trade), review of the competitiveness of these Logistic services and relevant flanking policies (supply capacity development policies, services sectors structure and structural strategies, regulatory frameworks include laws and regulations governing the Logistics services supplied in the transport and distribution of pharmaceutical products) as well as relevant related institutional frameworks;
4. Provide an analysis of the challenges and opportunities with a view to suggest ways and means to improve these Logistics services in the transport and distribution of pharmaceutical products, identify potential reforms and export performance;
5. Collect and compile all relevant data, information and statistics of these Logistics services in Morocco (cross-border functions by Services suppliers in terms of services sales, related-data on supply of such services through its affiliates, relevant associations and chambers of commerce). In case of non-available data, a Questionnaire might be developed and conducted and submitted to the relevant stakeholders to gather relevant information;
6. Conduct quantitative analysis of trade and statistical data related to the Logistic services in the transport and distribution of pharmaceutical products, referring when feasible, to WTO/GATS classification (Including the commitments taken by Morocco in the sector, if applicable, including assessment of challenges and opportunities from relevant multilateral, regional and bilateral trade arrangements, such as Arab Trade in Services Agreement, UMA, CFTA, EU Association Agreements and US bilateral FTA and any other Agreements covering the Logistic services supplied in the transport and distribution of pharmaceutical products between Morocco and third parties). The analysis would cover the four modes of services supply including market access conditions and restrictive measures, national treatment and MFN limitations, movement of natural person, cross border supply, consumption of the concerned services abroad, commercial presence, and requirements applied on foreign enterprises;
7. Identify the major market trend for these Logistical services in Morocco including the evolution and recent development of e-commerce and digital trade services and the potential impact of entry of new

key players in the logistical services supplied in the transport and distribution of pharmaceutical products in terms of competition and foreign investment. The evidence-based analysis should also look into the export potential of logistical services to foreign targeted markets. Particular attention would be given to the impact on job creation and reinforcement of the supply side capacity towards the realization of Sustainable Development Goals (SDGs);

8. Conduct interviews and meetings with multiple stakeholders, including relevant governmental agencies as well as the private sector organizations, consumer protection associations and chambers of commerce among others, in order to collect information and identify areas of interest of the stakeholders so as to assist the government in elaborating policy tools and strategic directions in this sector;

9. Prepare a questionnaire to collect non-available data and information to be used in the analysis. The interaction with national stakeholders should be with the aim to obtaining recent policy documents, statistics, other relevant data and information pertaining the Logistic services in the transport and distribution of pharmaceutical products. This exercise will be supported by the Ministry of Industry, Trade, Digital and Green Economy (MITDGE);

10. Participate in and contribute to technical discussions and activities related to the SPR process.

Individual consultants will be evaluated based on the following methodology:

Step I: Screening and desk review:

Applications will be first screened and only candidates meeting the following minimum requirements will progress to the pool for shortlisting:

- Bachelor's Degree in Economics and or International Development or any other related field.
- Minimum 5 years of practical experience in trade policy including trade in services and economic analysis.
- Excellent writing, editing and oral communications in French and Arabic Demonstrated experience in performing similar assignments in Morocco

Technical evaluation Criteria max 100 points (Weighted 70):

Bachelor's Degree in Economics and or International Development or any other related field (15 points);

Minimum 5 years of practical experience in trade policy including trade in services and economic analysis (20 points);

Experience in conducting assessments of regional trade agreements using assessment tools or methodologies, economic analysis, analytical works and knowledge of public-private partnerships and dialogue (15 points);

Experience in research and publication on trade, trade in distribution services for pharmaceutical products, regional trade agreements, trade policy and negotiations (15 points);

Financial Criteria - 30% of total evaluation

For those offers considered in the financial evaluation, the lowest price offer will receive 30 points. The other offers will receive points in relation to the lowest offer, based on the following formula: $(PI / P_n) * 30$ where P_n is the financial offer being evaluated and PI is the lowest financial offer received.

Step II: Final evaluation

The final evaluation will combine the scores of the desk review and the financial proposal with the following weights assigned to each:

Individual consultants will be evaluated based on the **cumulative analysis** methodology (weighted scoring method), where the award of the contract will be made to the individual consultant whose offer has been evaluated and determined as:

- Responsive/compliant/acceptable; and
- Having received the highest score out of a pre-determined set of technical and financial criteria specific to the solicitation.

Technical Criteria weight: 70%

Financial Criteria weight: 30%

Only Individual Consultants obtaining a minimum of 49 points (70%) on the Technical evaluation would be considered for the Financial Evaluation.
