# 3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS:

## I. Academic Qualifications:

Bachelor's degree (or higher education) in political science, public policy, public administration, development studies, social science or other relevant fields.

# II. Years of experience:

- Minimum 5 years of relevant experience in analysis and facilitation of issues and processes related to democratic governance and civic space in Cambodia;
- Solid experience in providing strategic coordination and establishing inter-relationships with government and development partners;
- Knowledge and understanding of development challenges in Cambodia, including an understanding of inclusive dialogue, democratic governance and participation;
- Sound technical knowledge on project management, monitoring and evaluation and analysis report writing;
- Familiarity with UN programming modalities;
- Ability to facilitate diverse group discussion and workshop;

# **III. Competencies:**

- Solid analytical skills
- Excellent communication skills (spoken, written and presentational);
- Independent and initiative working
- Good interpersonal skills and ability to work in and with teams;

## IV. Language Requirements:

Fluency in English and Khmer language (spoken and written)

### 4. FINANCIAL PROPOSAL

This is a <u>Lump sum output-based contract</u>. Therefore, the interested offerors are requested to submit <u>Final All-Inclusive Price</u> with cost breakdown.

## **5. EVALUATION**

Offerors will be evaluated based on the **Cumulative analysis**.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the Offerors who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

# 5. 1. Technical qualification evaluation criteria:

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Only the offerors who have attained a minimum of 70% of total points will be considered as technical qualified offerors.

## 5. 2. Financial/Price Proposal Comparison:

- Only the financial/price proposal of offerors who have attained a minimum of 70% score in the
  technical qualification evaluation will be considered and evaluated. The total number of
  points allocated for the price component is 100. Below is the formula used for this evaluation:
- Rating for Financial Proposal = (Lowest Priced Offer / Price of the Offer Being Reviewed) x 100

## 5.3. Selection Method and Award Criteria:

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

Responsive/compliant/acceptable, and

 Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula: Total Score = Technical Qualification Score x 70% + Financial Score x 30%
