#### **BACKGROUND**

The European Union and the United Nations have launched the Spotlight Initiative (SI), a multi-year programme aimed at addressing all forms of violence against women and girls (VAWG), and harmful practices. The Spotlight Initiative (SI) aims to support transformative change on the ground to end VAWG, in numerous countries globally, including the Kyrgyz Republic. The initiative comes with the highest level of commitment globally and will be governed by the UN Deputy Secretary General and the Vice President of the EU Commission.

The SI in the Kyrgyz Republic will apply a comprehensive set of approaches based on social innovation, Human Rights, multi-sectoral inclusive response and survivor-centred principles to the planning, coordination, implementation and monitoring of interventions across the SI's six Outcome Areas. Particular emphasis will be placed on integrating the voices and experiences and solutions of women and girls who face multiple forms of discrimination, in line with the Sustainable Development Goals (SDG) principle of 'Leave No One Behind'. The SI in the Kyrgyz Republic has sought to reflect on current or common place models of 'conducting business' in order to propose innovative alternatives aligned with commitments to gender transformative and community-led approaches guided by adaptive leadership and a joint-One UN systems management approach.

The UN Coordination Unit is responsible for the SI Kyrgyz Republic programme management, working under the supervision and guidance of the UN Resident Coordinator (RC), Country Programme National Steering Committee, the National Civil Society Reference Group, the EU Delegation in Kyrgyzstan, and other stakeholders and partners engaged in programme implementation. This unit is comprised of the Programme Coordinator (hosted by RCO), M&E Specialist (hosted by RCO), Technical Coherence Specialist (hosted by UNW), and the Communication Specialist (hosted by UNICEF). These staff make up the SI Kyrgyz Republic core functions. In order to ensure adequate implementation and integration across Pillars, the UN Coordination Unit will work with all Recipient United Nations Organizations (RUNOs): UN Women, UNDP, UNFP, UNICEF and UNODC and associated UN agencies (IOM, WHO and OHCHR).

In order to streamline integration and collaboration across RUNOs, the SI Kyrgyz Republic has designated technical Pillar Leads based on decision of UN RC:

Pillar 1 (Laws and Policies) – UNDP,

- Pillar 2 (Institutional Strengthening) UNDP,
- Pillar 3 (Prevention) UNICEF,
- Pillar 4 (Quality Services with Focus on Prevention and Resilience) UNFPA,

- Pillar 6 (Women's Movement and CSOs) UN Women.

### **OBJECTIVE**

The main objective of the assignment is to support Country Programme Gender Coordinator/Spotlight Project Manager in facilitating effective coordination and implementation of the UNDP led pillars 1 and 2 under Spotlight Initiative and coordination of UNDP-assigned activities in the other pillars with relevant RUNOs and stakeholders.

#### **SCOPE OF WORK**

Under the direct supervision of the Country Programme Gender Coordinator/Spotlight Project Manager, and the overall guidance of Rule of Law Advisor/Project coordinator and the SDG16 Team Leader, the Legal expert will perform the following tasks:

• In consultation with the Spotlight Technical Team and key justice stakeholders, support in provision of the analysis of the key results, available gaps, recommendations and the work done, by the selected contractor engaged in monitoring development of Legislative review of the women's rights & Violence against Women and Girls (VAWG) and capacitating of the relevant bodies of Jogorku Kenesh and Ombudsman's Office. The review shall also focus on assessing compliance of the domestic legal framework with international standards, as well as the intersecting forms of discriminations under criminal, civil, family, labour, administrative and all other cross sectoral relevant legislation. As a result, the review is expected to be used by national stakeholders, including the government, the Parliament, the Ombudsman, and CSOs, as a tool for advocacy, reform, and produce legislative amendments and recommendations that might contribute to increased protection of women and girls against violence.;

- •Support in provision of the analysis of the key results, available gaps, recommendations and the work done, by the selected contractor engaged in managing grants to **CSOs and women's rights organizations to provide inputs to legislative and policy-making on SGBV**, conduct public oversight and participate in public hearing and inquiries on implementation of selected laws & policies on women's rights and SGBV;
- •Support in provision of the analysis of the key results, available gaps, recommendations and the work done, by the selected contractor engaged in strengthening the institutional capacities of the selected Parliamentarians, Parliamentary Committees of the Jogorku Kenesh, including establishing a cross-sectoral Working Group to advocate for, draft new and/or strengthen existing legislation and/or policies to conduct oversight of legislation on VAWG, strengthen legislation and hold state institutions accountable for implementation of selected legislation on women's rights and SGBV;
- •Support in provision of the analysis of the key results, available gaps, recommendations and the work done, by the selected contractor engaged in strengthening the institutional capacity of the **Department for Protection of Children's, Women's and Family Rights of the Ombudsman** to advocate for, monitor, report and increase public interface with CSOs on women rights' issues and VAWG);
- •Support in provision of the analysis of the key results, available gaps, recommendations and the work done, by the selected contractor engaged in conducting **internal gender assessment of justice and security** institutions (police, Advokatura, General Prosecutor Office, judiciary), including assessment of capacity to deliver on survivor-centered SGBV programmes, and to develop subsequent action plans
- •Expert support to the Rule of Law Advisor in provision of the analysis of the key results, gaps, recommendations and the work done, by the selected contractor engaged in **development and institutionalization of mandatory educational curriculum** for security & justice actors (police, judges, prosecutors and lawyers), the Management Academy under the President to enhance institutional gender-sensitive and survivor-centred criminal justice practices
- Expert support to the Access to Justice Advisor/Project Coordinator in provision of the analysis of the key
  results, gaps, recommendations and the work done, by the selected contractor engaged in support to the
  MoJ, through the work of the Bus of Solidarity, to conduct an effective public campaign on women's
  rights and EVAWG, targeting communities in rural and remote areas, to promote legal awareness as a
  tool to challenge discriminatory social norms, gender stereotypes and to contribute to increased women
  and girls' empowerment to claim equality before the law;
- Expert support in elaboration of TOR, then in analysis of the key results, available gaps, recommendations
  and the work done, by the selected contractor engaged in conducting a functional review of the national
  women rights network, including UNiTE, to identify strategic areas and develop a road map for the
  movement to be more strategic and coordinated at national and regional level;
- Support in ensuring project content wise document workflow maintenance, maintaining SI project communication with relative stakeholders, communication with SI communication unit for timely contribution.

## **REPORTING REQUIREMENTS**

Legal Expert shall submit progressive/interim and final reports in English language based on the results achieved according to set deadlines in agreed format stated all actions taken during the assignment to be approved by Country Programme Gender Coordinator/Spotlight Project Manager, and the overall guidance of Rule of Law Advisor/Project coordinator and the SDG16 Team Leader, which will serve as a justification for the payments. The certifying officer is SDG16 Team Leader.

## **QUALIFICATION REQUIREMENTS**

- Minimum Bachelor's degree or equivalent in Law;
- Proven experience working in the area of rule of law/ human rights/SGBV/gender equality at least 2 vears:
- Experience in conduction/participation of analysis of laws/draft laws/legislation;

- Experience in working with diverse partners including state bodies, CSOs, international organizations and development projects;
- Language skills: fluency in Russian and English is required;
- Knowledge of Kyrgyz will be an asset.

## ADDITIONAL REQUIREMENTS FOR RECOMMENDED CONTRACTORS

#### Statement of Medical Fitness for Work

Individual Consultants/Contractors whose assignments require travel and who are over 65 years of age are required, at their own cost, to undergo a full medical examination including x-rays and obtaining medical clearance from an UN - approved doctor prior to taking up their assignment.

Where there is no UN office nor a UN Medical Doctor present in the location of the Individual Contractor prior to commencing the travel, either for repatriation or duty travel, the Individual Contractor may choose his/her own preferred physician to obtain the required medical clearance.

## **Inoculations/Vaccinations**

Offerrors will be evaluated based on the methodology of *cumulative analysis*.
