# A. GENERAL PROVISIONS 1. Introduction Bidders shall adhere to all the requirements of this ITB, including any 1.1 amendments made in writing by UNDP. UNDP is under no obligation to award a contract to any Bidder as a result of this ITB. UNDP reserves the right to cancel the procurement process at any stage 1.3 without any liability of any kind for UNDP, upon notice to the bidders or publication of cancellation notice on UNDP website. 1.4 As part of the bid, it is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website (www.ungm.org). - 4.2 In the event of any uncertainty in the interpretation of a potential conflict of interest, Bidders must disclose to UNDP, and seek UNDP's confirmation on whether or not such conflict exists.
- 4.3 Similarly, the Bidders must disclose in their Bid their knowledge of the following:

- 14.7 JV, Consortium or Associations are encouraged for high value, multisectoral requirements when the spectrum of expertise and resources required may not be available within one firm.

# 15. Only One Bid

- 15.1 The Bidder (including the individual members of any Joint Venture) shall submit only one Bid, either in its own name or as part of a Joint Venture.
- 15.2 Bids submitted by two (2) or more Bidders shall all be rejected if they are found to have any of the following:
  - a) they have at least one controlling partner, director or shareholder in common; or
  - b) any one of them receive or have received any direct or indirect subsidy from the other/s; or
  - c) they have the same legal representative for purposes of this ITB; or
  - d) they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the Bid of another Bidder regarding this ITB process;
  - e) they are subcontractors to each other's Bid, or a subcontractor to one Bid also submits another Bid under its name as lead Bidder; or some key personnel proposed to be in the team of one Bidder participates in more than one Bid received for this ITB process. No verbal statement made during the conference shall modify the terms and conditions of the ITB, unless specifically incorporated in the Minutes of the Bidder's Conference or issued/posted as an amendment to ITB.

#### C. SUBMISSION AND OPENING OF BIDS

#### 22. Submission

- 22.1 The Bidder shall submit a duly signed and complete Bid comprising the documents and forms in accordance with requirements in the BDS. The Price Schedule shall be submitted together with the Technical Bid. Bid can be delivered either personally, by courier, or by electronic method of transmission as specified in the BDS.

#### 1. PROJECT BACKGROUND

# a. Project description

This project connects two important FFS projects – the Old Danedan WTP was recently completed by FFS and feeds several neighborhoods (a total of some 50,000 people), the West-Mosul General Hospital, and the textile factory area; and the Waladi Textile Factory provides jobs to some 4,000 people and is currently under procurement by FFS. This project is to repair the underground pipe between al-Danedan WTP and the factory area, and to install a booster station, water reservoir, firefighting system and elevated water tank at the factory to make sure the water is pumped to all destinations.

# 3. BUILDING/CONSTRUCTION DESCRIPTION

The old pumps of the booster station are stolen and fittings are damaged, main reservoirs and elevated tank are too badly damaged to be serviceable. The booster station will consist of four pumps each with a capacity of 250 m3/hr., (1+1) Pumps one on-duty and one on standby for drinking water including fittings and ultrasonic level meters for the reservoirs. Also, the work includes repairing damages of the main transmission pipe line which damaged in many places starting from Old Danadan WTP up to the main water reservoir, approximately 5,000m away.

**4. DESCRIPTION OF THE DAMAGE.** The textile factory and the pump stations were damaged during the liberation of the city. Damage to the underground water pipe is unclear and needs to be tested before the final repairs can be made.
